EXPLANATORY NOTE.

The Reinstatement in Civil Employment Act, 1944, places an obligation on the former employer to take back into his employment ex-employees covered by that Act. The purpose of the present Order is to provide that the restrictions on engagement imposed by the Orders in the Schedule shall not hamper the fulfilment of that obligation.

VARIATION OF ORDERS, BYELAWS, etc.

ORDER, DATED 9TH JUNE, 1944, MADE BY THE MINISTRY OF HOME AFFAIRS
UNDER THE DELEGATION OF EMERGENCY POWERS (MINISTRY OF
HOME AFFAIRS FOR NORTHERN IRELAND) ORDER, 1944.

WHEREAS by the Delegation of Emergency Powers (Ministry of Home Affairs for Northern Ireland) Order, 1944, (in this Order referred to as "the Order of 1944") the Secretary of State delegated to the Ministry of Home Affairs the powers which, under the Delegation of Emergency Powers (Ministry of Public Security for Northern Ireland) Order, 1942 (in this Order referred to as "the Order of 1942") had been delegated to the Ministry of Public Security, and revoked the Order of 1942:

AND WHEREAS by paragraph (4) of Article 1 of the Order of 1944 it is provided that the powers delegated to the Ministry of Home Affairs by the said Article 1 should extend to the variation or revocation of (*inter alia*) any order, rule or byelaw made, or direction, approval, authority or permission given, by the Ministry of Public Security under any of

the powers delegated by the Order of 1942, or any Order revoked by that Order, and being in force immediately before the coming into operation of the Order of 1944 :

NOW, THEREFORE, the Ministry of Home Affairs for Northern Ireland, in exercise of the powers delegated to it by the Order of 1944, and of all other powers enabling it in that behalf, hereby orders as follows :—

1. Any reference to the Ministry of Public Security in any order, rule or byelaw made, or direction, approval, authority or permission given, by that Ministry under any of the powers delegated by the Order of 1942, or any Order revoked by that Order, and being in force immediately before the coming into operation of the Order of 1944, shall, as from the date of this Order, be construed as a reference to the Ministry of Home Affairs.

2. This Order may be cited as the Variation of Orders, Byelaws, etc. (Northern Ireland) Order, 1944.
