

(d) In the form of Estimate—

(i) under the item "GENERAL ANAESTHETICS", the sum of 10s. 0d., shall be substituted for the sum of 7s. 6d. ;

(ii) the word "CROWNING" shall be substituted for the word "CROWNS" ; and

(iii) after the item "CROWNING", the following items shall be added :—

PROVISIONAL SPECIAL ORDER, DATED 4TH NOVEMBER, 1944, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR, ACTING JOINTLY, UNDER PARAGRAPH (m) OF PART II OF THE FIRST SCHEDULE TO THE NATIONAL HEALTH INSURANCE ACT, 1936.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly, hereby certify under sub-section (7) of section 168 of the National Health Insurance Act, 1936, that it is expedient that this order should come into operation forthwith, and in pursuance of the powers conferred by paragraph (m) of Part II of the First Schedule to that Act, and of all other powers enabling them in that behalf, hereby make the following order to come into operation forthwith as a provisional order :—

1.—(1) This order may be cited as the National Health Insurance (Subsidiary Employments) Amendment Order (Northern Ireland), 1944.

(2) The Interpretation Act, 1921, applies to the interpretation of this order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. The following provision shall be substituted for the provisions relating to employment as an auxiliary watcher by the Board of Trade, the Ministry of Shipping or the Admiralty contained in Part II of the First Schedule to the National Health Insurance (Subsidiary Employments) Order (Northern Ireland), 1938 (a), as subsequently amended (b) (hereinafter referred to as "the principal order") :—

"Employment ordinarily involving less than 28 hours' service weekly by the Board of Trade, the Admiralty, the Ministry of War Transport or other Government Department, as an auxiliary watcher."

3. The first paragraph of Part IV of the First Schedule to the principal order shall be amended as follows :—

(1) In sub-paragraph (a), the words "Ministry of War Transport or other Government Department" shall be inserted after the words "Board of Trade".

(2) In sub-paragraph (c), the words "Board of Trade" shall be deleted and the words "of any Government Department" shall be inserted after the words "life-saving apparatus".
