

**Non-British Subjects**

REGULATIONS, DATED 20TH SEPTEMBER, 1945, MADE BY THE MINISTRY OF LABOUR UNDER THE DISABLED PERSONS (EMPLOYMENT) ACT (NORTHERN IRELAND), 1945, IN RESPECT OF NON-BRITISH SUBJECTS.

1945. No. 112

The Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry"), by virtue of the powers conferred on it by the Disabled Persons (Employment) Act (Northern Ireland), 1945, and by sub-Section 2 of Section 22 of an Act of the Parliament of the United Kingdom cited as "the Disabled Persons (Employment) Act, 1944", and of all other powers enabling it in that behalf, hereby makes the following regulations :

1.—(1) These Regulations may be cited as the Disabled Persons (Non-British Subjects) Regulations (Northern Ireland), 1945, and shall come into force on the date hereof.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(3) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them, that is to say :—

"the Act" means the Disabled Persons (Employment) Act (Northern Ireland), 1945 ;

"war service" means service since the first day of September, 1939,—

- (a) in His Majesty's Armed Forces, or in the Allied or other foreign forces serving in association with His Majesty's Armed Forces ; or
- (b) in the Merchant Navy or Mercantile Marine ; or
- (c) as master or member of the crew of a merchant ship of any Power allied with His Majesty or of any Power which, at the date of such service, was at war with any other Power with which His Majesty was at war ; or
- (d) being, in the case of a woman, wholetime service in any of the capacities mentioned in the First Schedule to the Act or wholetime service with the Allied or other foreign forces serving in association with His Majesty's Armed Forces ;

or any service or employment since the said date which the Ministry considers may properly be treated for the purpose of these Regulations in the same manner as any such service as aforesaid.

2. Subject to the provisions of Regulation 3 of these Regulations, the Act shall apply to persons who are not British subjects in the same manner as it applies to persons who are British subjects.

Application of Act to non-British subjects.

3. The Act shall not apply to any person who is not a British subject unless he is for the time being within Northern Ireland and satisfies the Ministry either—

Conditions to be satisfied by non-British subjects.

- (a) that he is a person who has been engaged in war service for a period of, or for periods amounting in the aggregate to, not less than twelve months ; or
- (b) that, having regard to all the circumstances of his case, and in particular to the length of his period of residence, to his occupation in Northern Ireland and to the date and cause of any disability from which he may be suffering, he is a person to whom the Act ought to apply.

THE DISABLED PERSONS (REGISTRATION) REGULATIONS, 1945, DATED 21ST SEPTEMBER, 1945, MADE BY THE MINISTRY OF LABOUR UNDER THE DISABLED PERSONS (EMPLOYMENT) ACT (NORTHERN IRELAND), 1945.

The Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") by virtue of the powers conferred on it by the Disabled Persons (Employment) Act (Northern Ireland), 1945, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Disabled Persons (Registration) Regulations (Northern Ireland), 1945, and shall come into operation on the date hereof.

Short title, commencement and interpretation.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(3) In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them, that is to say :—
