

1. These Regulations may be cited as the Local Carriers' Regulations, 1945, and shall be construed as one with the Local Carriers' Regulations, 1935 (b) (hereinafter referred to as the "Principal Regulations").

2. The following words shall be added at the end of sub-paragraph (b) of Article 5 of the Principal Regulations: "or under the Road Transport Act, 1941".

3. The Local Carriers' Regulations, 1937 (c) are hereby revoked.

ORDER, DATED 16TH JANUARY, 1945, MADE BY THE MINISTER OF HOME AFFAIRS UNDER THE CONSTABULARY AND POLICE (IRELAND) ACT, 1919, AS APPLIED BY THE CONSTABULARY ACT (NORTHERN IRELAND), 1922.

I, THE RIGHT HONOURABLE EDMOND WARNOCK, K.C., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section 2 of the Constabulary Act (Northern Ireland), 1922, and by Section 4 of the Constabulary and Police (Ireland) Act, 1919, as applied by the said Act of 1922, and of all other powers enabling me in that behalf, do hereby order that in addition to the pay prescribed by the Royal Ulster Constabulary Pay Orders, 1922 to 1944, there shall be paid, with effect from the first day of September, 1944, a pensionable addition to pay to be known as 'war supplement' calculated at the rates and subject to the conditions prescribed in the Schedule to this Order.

And I certify that Sub-section (2) of Section 4 of the Constabulary and Police (Ireland) Act, 1919, which provides that a draft of any Order proposed to be made under the said Section shall be submitted to the representative body or bodies constituted by the Act and representing

any rank or ranks affected, and that before making the Order the Ministry of Home Affairs shall consider any representations made by such body or bodies, has been fully observed.

This Order may be cited as the Royal Ulster Constabulary Pay (Amending) Order, 1945, and shall be construed as one with the Royal Ulster Constabulary Pay Orders, 1922 to 1944 ; and those Orders and this Order may be cited together as the Royal Ulster Constabulary Pay Orders, 1922 to 1945.

This Order shall not apply to any woman appointed as a member of the Royal Ulster Constabulary.

SCHEDULE REFERRED TO IN FOREGOING ORDER.

1. For every week in which the annual value of the emoluments of a member of the Force—

- (a) does not exceed £1,000 he shall be granted a war supplement to his pay of 19/- ;
- (b) exceeds £1,000 but is less than £1,049 11s. he shall be granted a war supplement to his pay of a sum the annual value of which will, together with the annual value of his emoluments, equal the sum of £1,049 11s.

2. War Supplement shall be subject in every case to a deduction at the rate current for the time being in relation to pay as a contribution to the general pension charge of the Royal Ulster Constabulary.

3. Notwithstanding the provisions of Section 2 of the Constabulary and Police (Ireland) Act, 1883, no deduction in respect of barrack accommodation shall be made from the War Supplement prescribed in this Schedule.

4. In this Schedule :—

- (a) the expression ' emoluments ' means pay (other than war supplement) together with any war duty allowance, staff allowance less the amount of locomotion allowance appropriate to the rank of the member, retention allowance, rent allowance, or, where the member is provided with a house or quarters free of rent and rates, such sum as the Ministry may determine to be the rental value (inclusive of rates) of such house or quarters and any allowances which are in effect remuneration for special duties or responsibilities and do not represent recoupment of out of pocket expenses incurred in the performance of duty ;
- (b) the expression ' annual value ' in relation to any sum which is fixed with reference to a week, means fifty-two times that sum.
