POLICE EMPLOYMENT

ORDER, DATED 21ST DECEMBER, 1945, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER REGULATIONS 29B AND 98 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

In pursuance of the powers conferred on it by Regulations 29B and 98 of the Defence (General) Regulations, 1939, the Ministry of Home Affairs for Northern Ireland hereby orders as follows :—

1. The Police (Employment and Offences) (Northern Ireland) (No. 2) Order, 1941, is hereby revoked.

2. This Order shall come into force on the first day of January, 1946, and may be cited as the Police (Employment and Offences) (Revocation) (Northern Ireland) Order, 1945.

PUBLIC UTILITY UNDERTAKINGS

Prevention of Publications

ORDER, DATED 12TH JANUARY, 1945, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER REGULATION 56 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1945. No. 6

The Ministry of Commerce for Northern Ireland (hereinafter referred to as "the Ministry") by virtue and in-exercise of the powers under Regulation 56 of the Defence (General) Regulations, 1939, delegated to the Ministry by the Secretary of State under Regulation 102A of the said Regulations, hereby orders and directs as follows:—

1. The Public Utility Undertakings (Prevention of Publications) (Northern Ireland) Order, 1941 (a) shall be amended and shall have effect as if the following were deleted from the Schedule thereto:

"Any undertaking for the supply of electricity;"

2. This Order may be cited as the Public Utility Undertakings (Prevention of Publications) (Northern Ireland) (Amendment) Order, 1945, and shall come into force on the date hereof.
