## Order, dated 20th February, 1945, made by the Ministry of Commerce for Northern Ireland under Regulation 56 of the Defence (General) Regulations, 1939.

# 1945. No. 24

The Ministry of Commerce for Northern Ireland (hereinafter referred to as "the Ministry") by virtue and in exercise of the powers under Regulation 56 of the Defence (General) Regulations, 1939, delegated to the Ministry by the Secretary of State under Regulation 102A of the said Regulations, hereby orders and directs as follows :----

1. The Public Utility Undertakings (Prevention of Publications) (Northern Ireland) Order, 1941 (a), is hereby revoked.

2. Notwithstanding such revocation, the Harbour Authorities of Belfast and Londonderry shall not publish or permit to be published copies of the Accounts of their respective undertakings, or any report or other document relating to the operation of such undertaking which discloses information contained in such Accounts, before the expiration of a period of six months after the end of the year to which the Account relates.

The provisions of the Directions of the Ministry dated 9th May, 1942 (b), shall apply to such Accounts within the said period of six months.

3. The Ministry may at any time by notice in writing to the said Harbour Authorities relax or remove the restriction imposed by Article 2 of this Order.

This Order may be cited as The Public Utility Undertakings (Prevention of Publications) (Northern Ireland) Amendment Order (No. 2), 1945.

## EMERGENCY POWERS (DEFENCE).
