19. In these Regulations, unless the contrary intention appears, the following expressions have the meanings hereby assigned to them, that is to say :—

“allowances” includes premiums, grants and additional increments ;

“existing teacher” means a teacher to whom these Regulations apply, who was in the service on the date of the making of these Regulations or who, being temporarily out of the service on that date, subsequently re-enters the service as a principal teacher, privileged assistant, vice-principal, assistant, or junior assistant mistress ;

“preparatory school” and “secondary school” have respectively the meanings assigned to those expressions by the Secondary Schools Grants Regulations, Northern Ireland, 1937 ; and the expression “preparatory department” has the meaning assigned to the expression “preparatory school” ;

“qualified teacher” means a teacher entitled to be admitted to any of the salary scales for qualified teachers prescribed by these Regulations, and the expression “unqualified teacher” shall be construed accordingly.

REGULATIONS, DATED 17TH JULY, 1946, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as “the Ministry”) in pursuance of the powers vested in it by Sections 65, 69 and 99 of the Education Act (Northern Ireland), 1923, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Public Elementary Schools (Salaries and Allowances) (Amendment) Regulations (Northern Ireland), 1946.

(2) In these Regulations the expression “the principal Regulations” means the Public Elementary Schools (Salaries and Allowances) Regulations (Northern Ireland), 1946.

(3) These Regulations shall be construed as one with the principal Regulations, and shall have effect as from the date upon which those Regulations took effect.

2. Article 12 of the principal Regulations shall have effect as if after paragraph (4) thereof the following paragraph were added :—

“(5) Where after 1st April, 1945, two or more schools are amalgamated, re-organised or superseded in whole or in part by a new school (hereinafter referred to as an “amalgamated school”) and any principal teacher or privileged assistant of the schools so amalgamated, re-organised or superseded is retained as privileged assistant in the amalgamated school in accordance with the principal Regulations or any vice-principal or holder of the second post of special responsibility is so retained in the amalgamated school, he shall, so long as he is so retained in the amalgamated school, be entitled, in addition to salary, to any allowances to which under the said Regulations he was entitled in his former school on the day preceding the date of amalgamation, and the rate of any such allowance in the amalgamated school shall be that to which the teacher would have been entitled on the date of the amalgamation if he had continued to serve in his former school as principal, privileged assistant, vice-principal or holder of the second post of special responsibility, as the case may be, and if no amalgamation had taken place.

In this Regulation the expression “amalgamation” includes re-organisation and supersession.”

3. Article 16 of the principal Regulations shall have effect as if the following paragraph were added thereto :—

“For the purposes of determining the rate of any allowance or the scale salary payable to a teacher under these Regulations in respect of the year commencing 1st April, 1946, or any subsequent year the number of pupils on the rolls of a school shall, unless in special circumstances the Ministry otherwise determines, be taken to be the average number of pupils on the rolls of the school for the year ended 31st December, 1944 : Provided, however, that if the average number of pupils on the rolls of the school for each of two successive years ending 31st December so changes that had the average for each such year been the average number of pupils on the rolls of the school for the year ended 31st December, 1944, a different rate of allowance or scale salary would have been payable, then, subject to the fulfilment of the other conditions of these Regulations, that rate of

allowance or scale salary shall be payable as from 1st April following the two-yearly period in which the average number of pupils on the rolls of the school so changed, and shall continue to be payable until the 31st March following the end of a two-yearly period ending 31st December in each of which years the average number of pupils on the rolls of the school again so changes that a further change in the rate of salary or allowance is required to be made in accordance with the provisions of these Regulations."

**Public Elementary School (Teachers' War Service) Regulations,
Amending Regulations, No. 6.**

REGULATIONS, DATED 17TH JULY, 1946, MADE BY THE MINISTRY OF EDUCATION UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Section 6 of the Teachers' Salaries and Superannuation (War Service) Act (Northern Ireland), 1939, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1. These Regulations may be cited as the Public Elementary School (Teachers' War Service) Regulations, 1940, Amending Regulations, No. 6, 1946.

2. The Public Elementary School (Teachers' War Service) Regulations, 1940, as amended by subsequent Regulations, shall have effect subject to the following provisions of these Regulations.

3. For Sub-section (3) of Section (c) of Article 4 of the said Regulations there shall be substituted the following sub-section :—

"(3) Where the absent teacher is a principal, the teacher who discharges the duties of principal during such absence shall be eligible to receive—
