maxima in the five compulsory subjects as specified in Regulation 24 hereof, and

- either (i) pass in each of the aforesaid compulsory subjects,
 - or (ii) subject to the terms of Paragraph (2) of this Regulation pass in four of the compulsory subjects and compensate in the remaining compulsory subject; provided, however, that a candidate who takes a subsidiary language subject for the purpose of satisfying Paragraph (3) of Regulation 24 hereof may not compensate in another compulsory subject.
- (2) To compensate in English or in any subsidiary language subject a candidate must obtain at least 30 per cent. of the maximum marks and to compensate in any other subject at least 25 per cent. of the maximum marks."
- 5. These Regulations shall be construed as one with the Principal Regulations and shall come into operation on the date hereof.

Secondary Schools: Payment of Grants

REGULATIONS, DATED 31ST JULY, 1946, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

1946. No. 120

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 65, 69 and 77 of the Education Act (Northern Ireland), 1923, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Secondary Schools (Payment of Grants) Regulations (Northern Ireland), 1946.
- (2) In these Regulations the expression "the principal Regulations" means the Secondary School Grants Regulations, 1935, as amended by subsequent Regulations other than these Regulations.
- (3) These Regulations shall be construed as one with the principal Regulations.

- 2. The principal Regulations shall have effect in respect of attendances of pupils on and after 1st August, 1946, as if for Regulations 32, 33, 34 and 35 thereof there were substituted the following Regulations:—
- "32. Subject to the provisions of Regulation 33 hereof, a grant will be paid by the Ministry to the governing body of a recognised school in respect of each pupil who during the school year—
 - (a) has been between the ages of 5 and 19 years for at least six calendar months;
 - (b) has followed an approved course; provided that the Ministry may refuse to pay grant in respect of a pupil who is reported by an Inspector of the Ministry as being unfit to attend the class in which he is placed;
 - (c) has made at least 140 attendances at the school: provided that in the case of a pupil with less than 140 attendances a reduced grant calculated as follows will be paid:—

100 attendances but 2 of the appropriate rate specified in Regulation 33.

60 attendances but \frac{1}{3} of the appropriate rate less than 100 \tag{3}... specified in Regulation 33.

For the purposes of this Regulation, not more than five attendances shall be counted in any one week."

- "33. Subject to the reductions and additions specified in Regulation 35, grants under Regulation 32 will be payable at the following rates:—
 - (a) £7 in respect of each pupil in a recognised Preparatory school who has during the school year been less than 14 years of age for at least six calendar months;
 - (b) £7 in respect of each pupil in a recognised Intermediate or Secondary school who has reached the qualifying stage and has been under the age of 11 during any part of the school year;
 - (c) £11 in respect of each pupil in a recognised Intermediate or Secondary school who has reached the qualifying stage and has for at least six calendar months during the school year been between the ages of 11½ and 17: provided that this paragraph shall have effect with the substitution of 10½ for 11½ in any case where the approval of the Ministry has been obtained on or before the 1st January of the school year in in respect of which the grant is paid;
 - (d) £16 in respect of each pupil in a recognised Secondary school who has followed the course for the Senior Certificate Examination of the Ministry or other course regarded by the Ministry as its equivalent: provided, however, that where

pupils belonging to different years of the course of study are taught together in one class the grant in respect of each of these pupils shall be reduced by £5, unless sanction for such concurrent instruction has been given by the Ministry on or before 1st January of the school year in respect of which the grant is paid."

- "34. In respect of a pupil who has been transferred during the school year from one department of the school to another, the grant payable shall be determined by the Ministry."
- "35. The grants payable to a school under these Regulations in respect of attendances made by pupils on or after the 1st August, 1946, shall be subject to the following adjustments:—
 - (a) Where the amount of the grant does not exceed £1,500, that amount shall be increased by 8 per cent;
 - (b) Where the amount of the grant exceeds £1,500, but does not exceed £2,000, there shall be added thereto either the sum of £120 or such sum as will increase the amount of the grant to £2,000, whichever is the lesser;
 - (c) Where the amount of the grant exceeds £2,000, the amount of the excess over that sum shall be reduced by 8 per cent."
- 3. Regulations 3 and 4 of the Secondary School Grants Regulations, 1935, Amending Regulations No. 2, 1941, shall cease to have effect in respect of attendances made by pupils on and after the 1st August, 1946.
