Provided that a chemist shall not dispense a prescription requiring the manufacture by him of a preparation of penicillin for parenteral injection unless he holds a licence under the Therapeutic Substances Act, 1925, for that manufacture.

The National Health Insurance Joint Committee and the Ministry of Health and Local Government for Northern Ireland, acting jointly, in exercise of the powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1936 to 1946, and of all other powers enabling them in that behalf, hereby make the following regulations:—

- 1.—(1) These Regulations may be cited as the National Health Insurance (Medical Benefit) Amendment (No. 4) Regulations (Northern Ireland), 1946, and shall come into force on the thirty-first day of August in the year nineteen hundred and forty-six.
- (2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. The National Health Insurance (Medical Benefit) (Emergency Provisions) Regulations (Northern Ireland), 1942 (a) shall cease to have effect on the coming into force of these Regulations, but without prejudice to the validity of anything previously done thereunder or to any right, privilege, obligation or liability acquired, accrued or incurred thereunder.
