In pursuance of the powers conferred upon the Ministry of Finance by Section eight of the Government Loans Act (Northern Ireland), 1945, and of all other powers it thereunto enabling, the said Ministry hereby directs as follows :—

1. As from the date of the first Gale Day for repayment next occurring after the thirty-first day of July, 1946, in respect of any loan or instalment of a loan of the classes specified in the Schedule to this Order issued during the periods specified in the second, third and fourth columns of the said Schedule, the *maximum* rates of interest payable to the Government Loans Fund on the balances of such loans or instalments of loans then outstanding (after payment of all instalments due to such date) shall, thereafter, be the rates specified in that behalf in the said second, third and fourth columns of the said Schedule.

2. This Order may be cited as the Government Loans (Reduction in Rates of Interest) No. 1 Order (Northern Ireland), 1946.

As from the date of the first Gale Day for repayment next occurring after the dates specified in the second column of the Schedule to this Order, in respect of any loan or instalment of a loan of the classes specified in the first column of the said Schedule issued during the period from the twenty-second of November, 1921, to the thirty-first May, 1946, the *maximum* rates of interest payable to the Government Loans Fund on the balances of such loans or instalments of loans then outstanding (after payment of all instalments due to such date) shall, thereafter, be the rates specified in the third column of the said Schedule.
