

- (i) if an assistant or if the substitute for the absent principal—Principal's Allowance at the rate payable to a principal teacher of the school.
- (ii) if a vice-principal or a privileged assistant or a holder of the second post of special responsibility—the allowance at the rate payable under the last preceding paragraph or the allowance at the rate to which he is entitled as vice-principal or as privileged assistant or as holder of the second post of special responsibility whichever is the greater."

4. These Regulations shall be construed as one with the Public Elementary School (Teachers' War Service) Regulations, 1940, and shall have effect as from 1st April, 1945.

Regulations for the Secondary School Certificate Examinations, Amending Regulations, No. 6.

REGULATIONS, DATED THE 20TH NOVEMBER, 1946, MADE BY THE MINISTRY OF EDUCATION FOR NORTHERN IRELAND, UNDER SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1923, AND LAID BEFORE PARLIAMENT IN ACCORDANCE WITH THE PROVISIONS OF THAT SECTION.

1946. No. 203

1. These Regulations may be cited as "The Secondary School Examinations Regulations, Amending Regulations, No. 6, 1946".

2. The Secondary School Examinations Regulations, 1935 (Statutory Rules and Orders of Northern Ireland, 1935, No. 45) as amended by subsequent Regulations, are hereinafter referred to as The Principal Regulations.

3. The Principal Regulations shall have effect subject to the following provisions of these Regulations.

4. For Regulation 25 of the Principal Regulations, there shall be substituted the following Regulation :—

"25. (1) To qualify for the award of the Senior Certificate a candidate must obtain at least 40 per cent. of the sum of the

maxima in the five compulsory subjects as specified in Regulation 24 hereof, and

either (i) pass in each of the aforesaid compulsory subjects,
or (ii) subject to the terms of Paragraph (2) of this Regulation pass in four of the compulsory subjects and compensate in the remaining compulsory subject; provided, however, that a candidate who takes a subsidiary language subject for the purpose of satisfying Paragraph (3) of Regulation 24 hereof may not compensate in another compulsory subject.

(2) To compensate in English or in any subsidiary language subject a candidate must obtain at least 30 per cent. of the maximum marks and to compensate in any other subject at least 25 per cent. of the maximum marks."

5. These Regulations shall be construed as one with the Principal Regulations and shall come into operation on the date hereof.

Secondary Schools : Payment of Grants

REGULATIONS, DATED 31ST JULY, 1946, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1942, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 65, 69 and 77 of the Education Act (Northern Ireland), 1923, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Secondary Schools (Payment of Grants) Regulations (Northern Ireland), 1946.

(2) In these Regulations the expression "the principal Regulations" means the Secondary School Grants Regulations, 1935, as amended by subsequent Regulations other than these Regulations.

(3) These Regulations shall be construed as one with the principal Regulations.
