privilege, obligation or liability acquired, accrued, or incurred thereunder and the Ministry shall proceed in accordance with paragraph (e) of the said Regulation 3 as if the end of the period of the present emergency had been determined by order in Council.

(2) Notwithstanding anything in paragraph (e) of the said Regulation 3 advertisement in the local Press shall be deemed to constitute sufficient notification to the insured persons involved.

3. The words "after account has been taken of any adjustments in accordance with paragraph (a) of Regulation 3 of the National Health Insurance (Medical Benefit) Amendment Regulations (Northern Ireland), 1940", shall be deleted from paragraph (i) of Clause 93A of the First Schedule to the National Health Insurance (Medical Benefit) Regulations (Northern Ireland), 1938.

# Approved Societies' Investments Regulations (Northern Ireland), 1946

REGULATIONS, DATED 18TH DECEMBER, 1946, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

### 1946 No. 228

The Ministry of Labour and National Insurance, acting in conjunction with the Ministry of Finance, in exercise of the powers conferred by section 66 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations :—

# Contributory Pensions, Increase.

1.—(1) These regulations may be cited as the National Insurance (Approved Societies' Investments) Regulations (Northern Ireland), 1946.

(2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. As from the 23rd December, 1946, an approved society or the Ministry of Labour and National Insurance acting on behalf of an approved society shall not invest any further sums (including sums realised from investments) in any investments other than securities which are for the time being authorised by the Parliament of the United Kingdom as investments for savings banks funds, and subsections (1) and (3) of section 143 of the National Health Insurance Act, 1936 (which section relates to the investment of funds by approved societies) shall have effect accordingly :

Provided that this regulation shall not preclude the investment of any sum on or after the said 23rd December in any other security authorised by the said section if negotiations for such investment were entered into before that date.
