

Location of Industry (Restriction)

THE LOCATION OF INDUSTRY (RESTRICTION) ORDER (NORTHERN IRELAND), 1946, DATED 8TH APRIL, 1946, MADE BY THE MINISTRY OF COMMERCE UNDER REGULATION 55A OF THE DEFENCE (GENERAL) REGULATIONS, 1939, AS HAVING EFFECT BY VIRTUE OF THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) ACT, 1945, (a).

WHEREAS by letter of delegation dated 20th May, 1941, given by the Board of Trade under Paragraph (2) of Regulation 55A of the Defence (General) Regulations, 1939, the Board of Trade delegated to the Ministry of Commerce for Northern Ireland (in this Order referred to as "the Ministry") their functions under the said Regulation to provide by Order for the matters specified in the said Regulation as respects any area in Northern Ireland.

NOW, THEREFORE, the Ministry by virtue and in exercise of the powers so delegated to it as aforesaid and of all other powers enabling it in that behalf and by virtue of the Supplies and Services (Transitional Powers) Act, 1945, and Orders in Council made thereunder, (a) hereby orders that the Location of Industry (Restriction) Order, 1945, (b) shall cease to have effect on the 30th April, 1946.

EXPLANATORY NOTE

Under the Location of Industry (Restriction) Order, 1945, now revoked, it has been necessary to secure a licence from the Ministry of Commerce before use could be made of certain classes of factory and storage premises, *i.e.*, with certain exceptions, premises having an aggregate floor space of 3,000 square feet or more.

The revocation of the Order in no way affects any licensing requirement, *e.g.*, a licence to manufacture, which may exist under other Government regulations.
