ORDER, DATED THIRTEENTH JUNE, 1946, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER SECTION FOURTEEN OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

1946. No. 84

The Ministry of Home Affairs for Northern Ireland in exercise of the powers conferred on it by Section Fourteen of the Elections and Franchise Act (Northern Ireland), 1946, DOETH HEREBY ORDER as follows, that is to say :—

1. Part I of the Schedule to the Electoral Register (Postponement of Publication) Order, 1946, shall have effect as if for the references therein to the 18th June and 25th June there were substituted references to the 20th June and 27th June respectively.

2. The latest date for the receipt of a claim to be registered as a local government elector in the Register of Electors to be published on the 15th day of August, 1946, by virtue of the occupation of a part of a dwelling house in respect of which application has been made to the Commissioner of Valuation for a certificate of separate valuation shall, notwithstanding any provision to the contrary contained in the Electoral Register (Postponement of Publication) Order, 1946, be the 10th day of July, 1946 ;

Provided that no such claim shall be taken into consideration unless an application for a certificate of separate valuation relating to the part of the dwelling house occupied by the claimant shall have been received by the Commissioner of Valuation on or before the 17th day of June, 1946.

3. A list of the claims received by an Electoral Officer, pursuant to the foregoing provisions of this Order, after the 17th day of June 1946, and on or before the 10th day of July, 1946, shall be published by him as soon as may be after the said 10th day of July, 1946, and such list (hereinafter called the Supplementary List of Claims) shall, for the purposes of the Electoral (Register of Electors) Regulations (Northern Ireland), 1946, and of the Electoral Register (Postponement of Publication) Order, 1946, be deemed to form part of the list of claims published on the 20th day of June, 1946, pursuant to the provisions of the last mentioned Order as amended by this Order :

Provided that, notwithstanding any provision contained in the said Order as amended by this Order to the effect that no notice of objection to the registration of any person whose name is included in the list of claims published by any Electoral Officer may be given after the 27th day of June, 1946, objection may be made in the manner prescribed in the Electoral (Register of Electors) Regulations (Northern Ireland), 1946, to any entry in a Supplementay List of Claims within 7 days after the date of its publication.

4. This Order may be cited as the Electoral Register (Postponement of Publication) (Amendment) Order, (Northern Ireland), 1946.

Local Government, Casual Vacancies

REGULATIONS, DATED 21ST NOVEMBER, 1946, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION FIFTY-FOUR OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946.

WHEREAS it is provided in effect by paragraph (f) of sub-section (4) of section fifty of the Elections and Franchise Act (Northern Ireland), 1946, that if more than one person is duly nominated to fill a casual vacancy in any local authority other than the council of a county borough or other borough a poll shall be taken in the prescribed manner ;

NOW, THEREFORE, the Ministry of Home Affairs for Northern Ireland, in exercise of its powers under section fifty-four of the said Act and of every other power it thereunto enabling, hereby makes the following Regulations :—
