REGULATIONS, DATED 24TH MAY, 1946, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER THE ELECTIONS & FRANCHISE ACT (NORTHERN IRELAND), 1946.

#### 1946. No. 94

Whereas the Ministry of Home Affairs for Northern Ireland made Regulations entitled the Electoral (Register of Electors) Regulations, 1946 (hereinafter referred to as the "Principal Regulations"):

AND WHEREAS it is expedient that the Principal Regulations should be amended in manner hereinafter appearing:

Now, THEREFORE, the Ministry of Home Affairs for Northern Ireland in pursuance of the powers conferred upon it by the Elections & Franchise Act (Northern Ireland), 1946, and all other powers it thereunto enabling hereby makes the following Regulations amending the Principal Regulations, that is to say:—

- 1. For the forms "B.F. 10 (N.I.) Claim to be Registered as an Elector", "Form of List of Claimants" and "Form of List of Persons in Electors Lists Objected to "set out in the Second Schedule to the Principal Regulations there shall be substituted respectively the forms set out in Part I of the Schedule to these Regulations.
- 2. The Second Schedule to the Principal Regulations shall have effect, as if the form "Form of List of Claimants Objected to" set out in Part II of the Schedule to these Regulations were inserted after the form "Form of List of Persons in Electors Lists Objected to".
- 3. These Regulations may be cited as the Electoral (Register of Electors) (Amendment) Regulations (Northern Ireland), 1946, and shall be construed as one with the Principal Regulations.
