may lawfully be supplied or acquired on the surrender of one unit in lieu of the number of units (namely six, four and three respectively) hitherto required by the said Order to be surrendered on the supply or acquisition of the said item and accordingly the said Order shall have effect as if the number " 1 " were specified opposite the reference in the Schedule thereof to each of the said items respectively as the appropriate number of units to be surrendered in relation to that item.

3.—(1) This Order shall come into operation on the 11th day of February, 1947.

(2) This Order may be cited as the Utility Furniture (Supply and Acquisition) (Northern Ireland) Order, 1947, and this Order and the said Utility Furniture (Supply and Acquisition) (Northern Ireland) Order, 1946, may together be cited as the Utility Furniture (Supply and Acquisition) (Northern Ireland) Orders, 1946 and 1947.

THE UTILITY FURNITURE (SUPPLY AND ACQUISITION) (NORTHERN IRELAND) (NO. 2) ORDER, 1947, DATED 10TH OCTOBER, 1947, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

In exercise of the powers delegated to it under Regulation 55 of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, as extended by the Supplies and Services (Extended Purposes) Act, 1947, and of all other powers it enabling, the Ministry of Commerce for Northern Ireland hereby makes the following order :—

1. The Utility Furniture (Supply and Acquisition) (Northern Ireland) Order, 1946 (c), as amended by the Utility Furniture (Supply and Acquisition) (Northern Ireland) Order, 1947, shall have effect as if the following items were included in the Schedule to the first mentioned Order :—

### Grass Seeds and Fertilisers

THE GRASS SEEDS AND FERTILISERS (NORTHERN IRELAND) (AMENDMENT) ORDER, 1947, DATED JANUARY 17, 1947, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER REGULATION 62 OF THE DEFENCE (GENERAL) REGULATIONS, 1939, AS HAVING EFFECT BY VIRTUE OF THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) ACT, 1945 (a).

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers under Regulation 62 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) (No. 2) Order, 1943 (b), made by the Secretary of State under paragraph (1) of Regulation 102A of the said Regulations, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945, and an Order in Council made thereunder hereby orders and directs as follows :—

1. The Grass Seeds and Fertilisers (Northern Ireland) General Order, 1946, (in this Order referred to as "the principal Order") shall have effect—

- (i) as if for the reference in the proviso to Article 4 thereof to the first day of September, 1942, there were substituted a reference to the first day of September, 1943; and
- (ii) as if for the Schedule thereto there were substituted the Schedule to this Order—
