JURORS' LISTS : REMUNERATION AND EXPENSES

1947. No. 172

BY THE GOVERNOR IN PRIVY COUNCIL OF NORTHERN IRELAND

G R A N V I L L E

WHEREAS under and by virtue of the provisions contained in section nine of the Juries Procedure (Ireland) Act, 1876, the Lord Lieutenant, by and with the advice and consent of the Privy Council of Ireland, may from time to time make Orders fixing a scale or scales according to which the expenses of printing and the remuneration of Clerks of the Peace, Clerks and Rate Collectors of Poor Law Unions in carrying into execution the several purposes of the Juries (Ireland) Acts, and thereby made payable, shall be calculated and thereupon such expenses and remuneration shall in each case be calculated according to the scale or scales fixed by such Order, and for the time being in force, and not otherwise :

AND WHEREAS under and by virtue of the provisions of sub-sections (2) and (3) of section ninety-six of the Local Government (Ireland) Act, 1898, the expenses of all printing required in any county in connection with the said Juries (Ireland) Acts are leviable off the county at large :

AND WHEREAS under and by virtue of the provisions of sub-section (7) of section eighty-three of the said Local Government (Ireland) Act, 1898, as modified by section one hundred and twenty-one of the same Act, all the powers and duties of the Clerk of the Union under the said Juries (Ireland) Acts have in Unions where there is not an existing Clerk, as that expression is defined by sub-section (1) of section one hundred and nine of the said Act of 1898, been transferred so far as respects rural districts to the Secretary of the Council of the Administrative county in which any such rural district is situate, and so far as

respects every borough (whether a county borough or not) to the Town Clerk of such borough, and so far as respects every urban county district not being a borough to the Clerk of the Council of such urban district :

AND WHEREAS under and by virtue of the provisions of section eleven of the Jury Laws Amendment Act (Northern Ireland), 1926, where the Clerk of the Council of an urban district performs duties under subsection (7) of section eighty-three of the Local Government (Ireland) Act, 1898, in relation to Jurors' Lists that urban district is exempt from any county at large charge for raising the sums payable in respect of remuneration or expenses in connection with Jurors' Lists to the secretary of the council of the county in which that urban district is situate, to the clerk of any union in that county, or to the poor rate collector assisting such secretary or clerk of a union :

AND WHEREAS under and by virtue of the provisions of the said Local Government (Ireland) Act, 1898, the duties under the said Juries (Ireland) Acts formerly performed by Rate Collectors of Poor Law Unions are now performed so far as respects rural districts by Collectors, appointed by the Councils of the administrative counties in which such rural districts are respectively situate, and so far as respects urban districts by Collectors appointed by the District Councils of such districts :

AND WHEREAS under and by virtue of the provisions contained in section twenty-one of the County Officers and Courts (Ireland) Act, 1877, the Lord Lieutenant or other chief Governors of Ireland by and with the advice and consent of the Privy Council of Ireland may in fixing any scale or scales of remuneration of Clerks of the Peace under the Provisions of the Juries (Ireland) Acts, provide that any actual expenses shall be distinguished from any profits or remuneration presentable to and receivable by any Clerk of the Peace for his own use for or in respect of any duties imposed upon him by the Juries (Ireland) Acts, and thereupon such expenses and such profits and remuneration shall in each case be separately calculated, presented and paid according to the scale or scales fixed by such Order and for the time being in force and not otherwise, and the respective accounts thereof shall be audited and vouched as the Lord Lieutenant in Council may by order provide, and that after the union of the offices of the Clerk of the Crown and Clerk of the Peace for any County or Borough the amount of all profits and remuneration shall be presented to and receivable by His Majesty's Exchequer, but notwithstanding such union the amount of all such actual expenses as aforesaid shall continue to be presented and paid in the same manner as theretofore :

AND WHEREAS by the Government of Ireland Act, 1920, the Orders made thereunder, and the Irish Free State (Consequential Provisions)

Act, 1922, the powers of the Lord Lieutenant are now exercisable in Northern Ireland by the Governor of Northern Ireland :

AND WHEREAS the offices of Clerk of the Crown and Clerk of the Peace have been united in all Counties and Boroughs in Northern Ireland :

AND WHEREAS it is provided by sub-section (1) of section eighteen of the Jury Laws Amendment Act (Northern Ireland), 1926, that the said Act shall be construed as one with the Juries Acts and that the Juries Acts and the said Act may be cited together as the Juries Acts (Northern Ireland), 1871 to 1926 :

AND WHEREAS in pursuance of the foregoing statutes an Order in Council was duly made on the 30th day of April, 1928 :

AND WHEREAS it is now deemed expedient to revoke the said Order in Council, and to make a new Order instead thereof fixing a scale or scales according to which the expenses of printing and the remuneration of Clerks of the Crown and Peace, Secretaries of County Councils, Town Clerks of Boroughs, Clerks of Councils of Urban County Districts and Collectors of Poor Rate in carrying into execution the several purposes of the Juries Acts (Northern Ireland), 1871 to 1926, and thereby made payable, shall be calculated, and for the separate calculation of such expenses and such profits or remuneration of the Clerks of the Crown and Peace as aforesaid, and for the auditing and vouching of the respective accounts thereof :

NOW, THEREFORE, I, WILLIAM SPENCER, EARL GRANVILLE, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the advice and consent of His Majesty's Privy Council in Northern Ireland and by virtue of the powers vested in me by the said recited enactments and by all other powers Me thereunto enabling, do hereby revoke the said Order in Council made on the 30th day of April, 1928 ; and hereby order that, subject to the provisions of section twelve of the Jury Laws Amendment Act (Northern Ireland), 1926, the following scale shall be, and the same is hereby fixed as the scale according to which the expenses of printing, and the remuneration of Clerks of the Crown and Peace, Secretaries of County Councils, Town Clerks of Boroughs, Clerks of Councils of Urban County Districts and Collectors of Poor Rate, in carrying into execution the several purposes of the Juries Acts (Northern Ireland), 1871 to 1926, and thereby made payable, shall be calculated, and in exercise of the powers conferred upon Me by section twenty-one of the County Officers and Courts (Ireland) Act, 1877, do hereby also order that the sums payable under

and by virtue of this Order in Council to the Clerks of the Crown and Peace under the Juries Acts (Northern Ireland), 1871 to 1926, shall henceforth be separately calculated, distinguished and apportioned as set out in paragraph (b) of Clause 1 of this Order, and I do hereby further order that the vouching and auditing of the said sums shall be in the manner directed by paragraph (c) of the said Clause 1.

1.—(a) Clerks of the Crown and Peace shall be paid at the rate of thirty pounds per annum for any number of names out of the total number of names on the Lists of General Jurors up to five hundred names, and one shilling for every additional name; and six pounds ten shillings per annum in addition for any number of names out of the total number of names on the Lists of Special Jurors up to five hundred names, and three pence for every additional name:

(b) The sums to be distinguished and paid as and for actual expenses shall be one-half of the amount yielded by the scale under paragraph 1 (a) of this Order, and the sums to be distinguished and paid as and for profits or remuneration in respect of the duties imposed upon the Clerks of the Crown and Peace by the Juries Acts (Northern Ireland), 1871 to 1926, shall be the remaining half of the said amount.

(c) Every Clerk of the Crown and Peace shall prepare an account stating the amount claimed by him as expenses and profits or remuneration for or in respect of any duties imposed upon him by the Juries Acts (Northern Ireland), 1871 to 1926, and setting forth such particulars as may be necessary to show how such amount is calculated, and shall transmit the said account to the Secretary of the County Council or the Town Clerk of the Borough or City Council by which such expenses and profits or remuneration are payable, and every such Clerk of the Crown and Peace shall produce to such Secretary or Town Clerk such lists of jurors and other documents as may be necessary to vouch the sums claimed in the said account, and to enable the said Secretary or Town Clerk to audit and ascertain the accuracy of the same, and such Secretary or Town Clerk shall audit the same accordingly.

2. Secretaries of County Councils, Town Clerks of Boroughs and Clerks of Councils of Urban County Districts shall be paid at the rate of two shillings and sixpence per name per annum for any number of names up to one hundred out of the total number of names returned by them in accordance with the terms of the precept and one shilling for every additional name so returned, provided that the total sum paid in respect of any one local financial year to any such Secretary, Town Clerk, or Clerk for the performance of duties under the Juries Acts (Northern Ireland), 1871 to 1926, in any County or Urban District shall in no case be less than twelve pounds ten shillings.

3. Collectors of Poor Rate shall be paid at the rate of three pounds ten shillings per annum to each Collector for any number of names up

to twenty-five, and sixpence for every additional name. The payment is to be calculated upon the number of names within the Collector's District which are returned by him as qualified in accordance with the terms of the precept.

4. Each Secretary of a County Council, Town Clerk of a Borough, and Clerk of an Urban County District shall be paid a sum of fifteen shillings for each day on which he is necessarily in attendance at the Court for the revision of Jurors' Lists in execution of his duties, and a sum of fifteen shillings for each night on which he is necessarily absent from his headquarters, together with the actual travelling expenses incurred in attending the Court.

Each Collector of Poor Rate shall be paid a sum of ten shillings and sixpence for each day on which he is necessarily in attendance at the Court for the revision of Jurors' Lists in execution of his duties, and a sum of ten shilling and sixpence for each night on which he is necessarily absent from his headquarters, together with the actual travelling expenses incurred in attending the Court.

Provided that no payment shall be made in respect of fees for attendance and travelling expenses unless the Crown Solicitor certifies in writing that the expenses claimed have been necessarily incurred by the Officers in the discharge of their duties.

5. All printing required in connection with the Juries Acts of lists, forms, notices, books, advertisements, or otherwise, whether required by any Clerk of the Crown and Peace, Secretary of a County Council, Town Clerk, or Clerk of an Urban District Council shall be done in accordance with a contract in the manner provided by sub-sections (2) and (3) of section ninety-six of the Local Government (Ireland) Act, 1898, and not otherwise unless in any exceptional case the County Council for special reasons so permit.

And I do hereby Order and Direct that this Order shall come into operation on the date of its notification in the *Belfast Gazette* and may be cited as the Jurors' Lists (Remuneration and Expenses) Order (Northern Ireland), 1947.
