

3. This Scheme shall apply to Nun Teachers employed in Mount Saint Catherine's Convent Public Elementary School, Armagh, subject to the proviso that the 8th September, 1937, shall be substituted for the 1st April, 1945, as the operative date for the purpose of this Scheme.

4. This Scheme may be cited as the Public Elementary Teachers' (Religious Orders) Superannuation Scheme, 1947.

**Public Elementary School (Teachers' War Service)
Regulations, Amending Regulations, No. 7.**

REGULATIONS, DATED 24TH FEBRUARY, 1947, MADE BY THE MINISTRY OF EDUCATION UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939, AS AMENDED BY THE TEACHERS' SALARIES (WAR SERVICE) (AMENDMENT) ACT (NORTHERN IRELAND), 1946, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by the Teachers' Salaries and Superannuation (War Service) Act (Northern Ireland), 1939, as amended by Section 1 of the Teachers' Salaries (War Service) (Amendment) Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1. These Regulations may be cited as the Public Elementary School (Teachers' War Service) Regulations, 1940, amending Regulations, No. 7, 1947.

2. In these Regulations—

(1) the expression "the Principal Regulations" means the Public Elementary Schools Regulations, 1934, as amended by subsequent Regulations other than these Regulations ;

(2) the expression "the said Regulations" means the Public Elementary School (Teachers' War Service) Regulations, 1940, as amended by subsequent Regulations other than these Regulations ;

(3) the expression "war service teacher" means a person who has undertaken war service before admission to, and satisfactory completion of, a course of training as a teacher in a Training College recognised for that purpose by the Ministry ;

(4) the expression "war service probationary teacher" means a person—

(a) who, having been admitted or accepted for admission to a Training College under an arrangement made by the Ministry, has undertaken war service before completing his course of training and who has not satisfactorily completed the probationary period ; or

(b) who, having completed his course of training as a teacher in a recognised Training College, has undertaken war service before satisfactorily completing the probationary period.

(5) the expression "probationary period" means the probationary period prescribed in paragraph (a) of Regulation 71 of "the Principal Regulations" as modified, in the case of a war service probationary teacher, by Regulation 5 of "the said Regulations" ;

(6) the expression "teacher" means a teacher as defined in "the Principal Regulations" ;

(7) the expression "recognised" means recognised by the Ministry.

3. Notwithstanding anything contained in "the Principal Regulations" or in "the said Regulations" ;

(1) The rate of salary of a war service teacher or a war service probationary teacher, while serving on probation as a teacher (other than a locum tenens teacher), shall be determined as if his period of war service had been approved teaching service, but no further increments shall be granted until he has satisfactorily completed the probationary period ;

(2) Such teacher shall, on satisfactory completion of the probationary period, be entitled to receive salary from the beginning of the probationary period at the rates which would have been warranted under "the Principal Regulations" if he had satisfactorily completed the probationary period on the date on which he would have so completed it had his war service been recognised teaching service.

Provided always that—

(a) this Regulation shall apply to a war service teacher only if he becomes employed as a teacher (which expression includes, in the case of a public elementary school, a locum tenens teacher and a substitute for a teacher) in contributing service before 1st April, 1948 ;

(b) where a war service probationary teacher undertook war service before completing his course of training at a recognised Training College, that part of his war service falling before such date as the Ministry may determine to be the date on which that course would have been completed shall, for the purpose of this Regulation, be deemed not to have been war service ;

(c) war service given by a war service teacher or a war service probationary teacher before attaining the age of eighteen years shall for the purpose of this Regulation be deemed not to have been war service ; and

(d) nothing in this Regulation or in " the Principal Regulations " or in " the said Regulations " shall entitle an untrained war service teacher or an untrained war service probationary teacher to a higher rate of salary than that warranted by paragraph (1) of this Regulation unless he had served before 1st January, 1947, as a public elementary school teacher (other than a locum tenens teacher) in respect of whose salary grants were paid by the Ministry.

4. These Regulations shall be construed as one with the said Regulations.
