

Quarter Sessions (Ireland) Act, 1858, section three of the County Officers and Courts (Ireland) Act, 1877, and paragraphs 1 and 2 of the First Schedule to the Irish Free State (Consequential Provisions) Act, 1922, (Session 2), the Governor of Northern Ireland may, by and with the consent of the Privy Council of Northern Ireland, remove any County Court Judge and Chairman of Quarter Sessions who assents to such removal from any county to any other county to act therein as County Court Judge and Chairman of Quarter Sessions ;

AND WHEREAS Isaac Copeland, Esquire, one of His Majesty's Counsel learned in the law is at present County Court Judge and Chairman of Quarter Sessions of and for the County of Tyrone ;

AND WHEREAS the office of Recorder of Londonderry has become and is now vacant ;

AND WHEREAS it is expedient to remove the said Isaac Copeland from the said County of Tyrone to act as Recorder of Londonderry ;

AND WHEREAS the said Isaac Copeland has assented to such removal ;

NOW, THEREFORE, I, WILLIAM SPENCER, EARL GRANVILLE, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the consent of the Privy Council of Northern Ireland, do hereby, pursuant to the powers vested in me under and by virtue of the enactments hereinbefore recited, and of every other power me thereunto enabling, remove the said Isaac Copeland from the said County of Tyrone and nominate and appoint him to act as Recorder of Londonderry, and to execute as Recorder all the powers and duties by law appertaining to that office.

Newtownhamilton Quarter Sessions

ORDER IN COUNCIL, DATED 10TH MARCH, 1947, MADE UNDER THE CIVIL BILL COURTS (IRELAND) ACT, 1851.

BY THE LORDS JUSTICES IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

WHEREAS under and by virtue of Proclamations made by the Lord Lieutenant and Privy Council of Ireland, a General Sessions of the Peace and Civil Bill Courts for hearing and determining causes by Civil Bill, and for transacting all such business (including appeals from Petty Sessions, but excluding all other criminal business) as may be cognizable or determinable at any General Sessions of the Peace, is held once in each year at the town of Newtownhamilton, in the County of Armagh, for the district or division of Markethill, in the said County of Armagh ;

AND WHEREAS by the Civil Bill Courts (Ireland) Act, 1851, it is, in effect, amongst other things, enacted that it shall be lawful for the Governor of Northern Ireland from time to time, by and with the consent of the Privy Council of Northern Ireland, to discontinue any town or place for holding Sessions ;

AND WHEREAS it has been represented by the County Court Judge of the said County of Armagh to the Minister of Home Affairs that, by reason of absence of business, the said town of Newtownhamilton should be discontinued as a Sessions town for the said County of Armagh ;

NOW, THEREFORE, WE, the Lords Justices for the government of Northern Ireland, in exercise of the powers conferred by the said Act, and by and with the consent and advice of the Privy Council of Northern Ireland, do hereby ORDER AND DIRECT that henceforth the said town of Newtownhamilton shall be discontinued as a Sessions town for the said County of Armagh ;

PROVIDED, however, that nothing herein contained shall be deemed or taken in any wise to annul, affect or alter the Proclamations hereinbefore referred to, or any of them, further or otherwise than may be necessary to give effect to this Order, but otherwise the said Proclamations shall remain in full force and effect.

This Order may be cited as the Newtownhamilton Quarter Sessions and Civil Bill Court (Discontinuance) Order (Northern Ireland), 1947.
