REGULATIONS, DATED 31ST MARCH, 1947, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

The Ministry of Labour and National Insurance, acting in conjunction with the Ministry of Finance, in exercise of the powers conferred by section 66 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations :---

1.—(1) These regulations may be cited as the National Insurance (Pensions Accounts) Regulations (Northern Ireland), 1947.

(2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—(1) All sums paid on or after the 1st April, 1947, on account of pensions which are payable under the Old Age Pensions Act (Northern Ireland), 1936, by virtue of any of the provisions of the Widows', Orphans' and Old Age Contributory Pensions Acts (Northern Ireland), 1936 to 1946, shall be met out of the Pensions Account (Northern Ireland), or, as the case may be, the Special Pensions Account (Northern Ireland).

(2) The provisions of the said Acts shall have effect subject to the modifications contained in the foregoing paragraph, and the following specific amendments shall apply as from the 1st April, 1947 ----

- (a) In subsection (1) of section 14 of the Widows', Orphans' and Old Age Contributory Pensions Act (Northern Ireland), 1936 (which subsection relates to the Pensions Account (Northern Ireland)) the words from "which are payable" to the end of the proviso shall be omitted.
- (b) In subsection (1) of section 6 of the Widows', Orphans' and Old Age Contributory Pensions (Voluntary Contributors) Act (Northern Ireland), 1937 (which subsection relates to the Special Pensions Account (Northern Ireland)) the words "under the principal Act" where those words occur for the second time, and the proviso to the subsection, shall be omitted.
