### Warble Fly (Dressing of Cattle)

WARBLE FLY (DRESSING OF CATTLE) (NORTHERN IRELAND) ORDER, 1947  
MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DISEASES OF ANIMALS ACTS 1894 TO 1935.

1947. No. 21

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Diseases of Animals Acts, 1894 to 1935, and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows :—

1. The Warble Fly (Dressing of Cattle) (Northern Ireland) (Suspension) Order of 1943 is hereby revoked as from 18th February, 1947, and as from the said date the Warble Fly (Dressing of Cattle) (Northern Ireland) Order of 1936 shall have effect as if the Warble Fly (Dressing of Cattle) (Northern Ireland) (Suspension) Order of 1943 had not been made.

#### *Short Title*

2. This Order may be cited as the Warble Fly (Dressing of Cattle) (Northern Ireland) Order of 1947.

### Examination of Accounts

MINUTE OF THE MINISTRY OF FINANCE REGARDING THE AUDIT OF CERTAIN ACCOUNTS BY THE COMPTROLLER AND AUDITOR-GENERAL UNDER SECTION TWENTY OF THE EXCHEQUER AND AUDIT ACT (NORTHERN IRELAND), 1921.

WHEREAS it is provided by Section twenty of the Exchequer and Audit Act (Northern Ireland), 1921, that the Comptroller and Auditor-General shall examine, if so required by the Ministry of Finance and in accordance with the regulations prescribed by the said Ministry, any accounts, whether relating directly to the receipt or expenditure of public funds or not, which the said Ministry may, by minute to be laid before Parliament, direct.

AND WHEREAS it appears expedient to the Ministry of Finance that certain Accounts hereinafter specified should be so examined :

NOW, THEREFORE, the Ministry of Finance hereby directs and requires the Comptroller and Auditor-General to examine the Accounts described hereunder, namely :—

(1) The Estates Trust Account.

(2) Every special account relating to a scheme for the destruction of vermin approved by the Ministry of Agriculture under the Agriculture (Destruction of Vermin) Act, 1942, so long as such account is, in accordance with the provisions of subsection (6) of Section one of that Act, required to be kept by the Ministry of Agriculture.

And the Ministry of Finance hereby prescribes the following Regulations in accordance with which the Accounts aforesaid shall be examined, namely :—

(i) The examination to be applied to the Accounts in so far as they relate to the payment or disbursement of monies shall be of the same character as that applied to the Appropriation Accounts in accordance with subsection (2) of Section eleven of the Government Loans and Exchequer Provisions Act (Northern Ireland), 1925.

(ii) The examination to be applied to the Accounts in so far as they relate to the receipt or collection of monies shall be of the same character as that applied to Accounts of the receipts of revenue in accordance with Section nineteen of the Exchequer and Audit Act (Northern Ireland), 1921.

(iii) In carrying out the examination as aforesaid, the Comptroller and Auditor-General shall observe any special requirements which the Ministry of Finance may from time to time impose in relation to either of the said Accounts.

(iv) The first examination shall, in relation to the Account numbered (1), cover the period commencing on the 1st

April, 1937, and shall, in the case of the Account numbered (2) cover the whole of the period from the commencement of that Account.

MINUTE OF THE MINISTRY OF FINANCE REGARDING THE AUDIT OF THE ACCOUNTS OF THE QUEEN'S UNIVERSITY OF BELFAST JOINT COMMITTEE FOR ADULT EDUCATION BY THE COMPTROLLER AND AUDITOR-GENERAL UNDER SECTION 20 OF THE EXCHEQUER AND AUDIT ACT (NORTHERN IRELAND), 1921 (12 GEO. V, c. 2).

WHEREAS it is provided by Section twenty of the Exchequer and Audit Act (Northern Ireland), 1921, that the Comptroller and Auditor-General shall examine, if so required by the Ministry of Finance and in accordance with the regulations prescribed by the said Ministry, any accounts, whether relating directly to the receipt or expenditure of public funds or not, which the said Ministry may, by minute to be laid before Parliament, direct.

AND WHEREAS it appears expedient to the Ministry of Finance that the accounts kept by the Queen's University of Belfast Joint Committee for Adult Education should be so examined :

NOW, THEREFORE, the Ministry of Finance hereby directs and requires the Comptroller and Auditor-General to examine the said accounts.

And the Ministry of Finance hereby prescribes the following Regulations in accordance with which the said accounts shall be examined, namely :

- (a) the examination to be applied to the accounts shall be of the same character as that applied to the Appropriation Accounts in accordance with Sections fifteen and sixteen of the Exchequer and Audit Act (Northern Ireland), 1921 ;
- (b) in carrying out the examination as aforesaid, the Comptroller and Auditor-General shall observe any special requirements which the Ministry of Finance may from time to time impose in relation to the said accounts ;
