This Order shall apply only in Northern Ireland. 3.

THE BELFAST CORPORATION TRAMWAYS AND TROLLEY VEHICLES (INCREASE OF FARES) ORDER, 1948, DATED 1ST JANUARY, 1948, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER PARAGRAPH (1B) OF REGULATION 56 OF THE DEFENCE (GENERAL) REGULATIONS, 1939, AS HAVING EFFECT BY VIRTUE OF THE SUPPLIES AND SERVICES (TRANSITIONAL POWERS) ACT, 1945 (a), AS EXTENDED BY THE SUPPLIES AND SERVICES (EXTENDED PURPOSES) Аст, 1947 (b).

In exercise of the powers under paragraph (1B) of Regulation 56 of the Defence (General) Regulations, 1939, as having effect by virtue of the Supplies and Services (Transitional Powers) Act, 1945 (a), as extended by the Supplies and Services (Extended Purposes) Act, 1947 (b), delegated to it by the Delegation of Emergency Powers (Ministry of Commerce for Northern Ireland) Order, 1945 (c), made by the Secretary of State under Regulation 102A of the said Regulations, as having effect as aforesaid, and of all other powers it enabling, the Ministry of Commerce for Northern Ireland (hereafter in this Order referred to as "the Ministry") hereby orders as follows :-

Notwithstanding any obligation or limitation imposed upon the 1. Lord Mayor, Aldermen and Citizens of the City of Belfast (hereafter in this Order referred to as "the Corporation ") by or by virtue of any Act or other instrument determining their functions, and subject to the conditions specified in Article 2 hereof, the power of the Corporation to charge fares on their tramways and trolley vehicle undertaking shall extend so as to enable the Corporation to charge such fares at a rate not exceeding three halfpennies per mile.

The conditions aforesaid are the following :----

- (i) that the exercise of the power of the Corporation to alter and introduce any fares by virtue of this Order shall be subject in every case to the approval of the Ministry;
- (ii) that the Corporation shall keep open for public inspection at all reasonable times at the office of the General Manager and Engineer, Sandy Row, Belfast, a list of any fares as altered by virtue of this Order;
- (iii) that the Corporation shall keep such accounts and shall make such returns of their receipts and expenditure and of their traffic as the Ministry may from time to time require;
- (iv) that the Corporation shall make reasonable provision for the proper repair, maintenance and renewal of their undertaking and shall keep such accounts of their expenditure upon such repair, maintenance and renewal and shall furnish such returns of the provision so made by them and of their estimated future liability in respect thereof as the Ministry may from time to time require.

This Order shall come into force on the fifth day of January, 3. 1948, and, unless previously revoked, shall continue in force until the 31st day of December, 1948, and shall then expire :

Provided that sub-section (2) of section thirty-eight of the Interpretation Act, 1889, (which relates to the effect of repeals) shall apply upon the expiry of the Order as if this Order were an Act which had then been repealed.

4. This Order may be cited as The Belfast Corporation Tramways and Trolley Vehicles (Increase of Fares) Order, 1948.
