REGULATIONS DATED THE 29TH DAY OF APRIL, 1948, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 99 OF THE EDUCATION ACT (NORTHERN IRELAND), 1947.

1948. No. 132

The Ministry of Finance, in exercise of the powers conferred upon it by subsection (1) of Section 99 of the Education Act (Northern Ireland), 1947, hereby makes the following Regulations :—

1. The requisition to be made to entitle any person to obtain a certified copy of the entry of the birth of any person whose age is required to be ascertained or proved for the purposes of the said Act, or of any enactment relating to the employment of children or young persons, shall be in the form set forth in the Schedule to these Regulations.

2. These Regulations may be cite 1 as the Certificates of Births (Requisition) Regulations (Northern Leland), 1948, and shall come into operation on the 1st day of May, 1948.

REGULATIONS, DATED 17TH JUNE, 1948, MADE BY THE REGISTRAR-GENERAL UNDER THE BIRTHS AND DEATHS REGISTRATION (IRELAND) ACTS, 1863 TO 1880, AND THE MARRIAGES (IRELAND) ACT, 1844, AS APPLIED BY SUBSECTION (1) OF SECTION 48 OF THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

1948. No. 163

The Registrar-General for Northern Ireland, in pursuance of the Births and Deaths Registration (Ireland) Acts, 1863 to 1880, and the Marriages (Ireland) Act, 1844, as applied by sub-section (1) of Section 48 of the National Insurance Act (Northern Ireland), 1946, and with the approbation of the Governor of Northern Ireland, hereby makes the following Regulations :—

1. These Regulations may be cited as the National Insurance (Verification of Births, etc.) Regulations (Northern Ireland), 1948.

2. Every Superintendent Registrar and every Registrar of Births, Deaths, and Marriages, and every Registrar of Marriages, on receiving from the Registrar-General a requisition for the verification of particulars relating to a birth, death, or marriage for the purposes of the National Insurance Act, (Northern Ireland), 1946, shall immediately search in the Indexes and Registers in his custody for an entry of the birth, death, or marriage (hereinafter referred to as the "event") of which particulars are given in the Requisition.
