- 2. Article 47 of the principal regulations as amended is hereby revoked.
- 3. Article 48 of the principal regulations as amended shall be deleted and the following article substituted therefor:—
 - 48. All the wheels of a trailer when the trailer is being drawn on a public road by a motor car or a heavy motor car shall be equipped with pneumatic tyres:

Provided that this Regulation shall not apply to —

- (a) trailers designed for use in works or on private premises and used on a road only in passing from one part of the works or premises to another or to works or premises in the immediate neighbourhood, or to trailers designed and used by or on behalf of local authorities for street cleansing or the collection or disposal of refuse;
- (b) any land implement or any agricultural trailer fitted with wooden or metal tyres which are smooth soled and which where the tyre touches the surface of the road are not less than 3 inches in width.
- 4. These Regulations may be cited as the Motor Cars (Use and Construction) (Amendment) (Northern Ireland) Regulations, 1948.

REGULATIONS, DATED 15TH DAY OF JUNE, 1948, MADE BY THE MINISTRY OF COMMERCE UNDER PART II OF THE MOTOR VEHICLES (Traffic AND REGULATION) ACT (NORTHERN IRELAND), 1926.

1948. No. 152

The Ministry of Commerce in exercise of the powers vested in it by Part II of the Motor Vehicles (Traffic and Regulation) Act (Northern Ireland), 1926, and of all other powers in that behalf thereunto enabling it, hereby makes the following Regulations, further amending the Public Service Vehicles Regulations, 1927 (a), (hereinafter referred to as "the Principal Regulations"), that is to say:—

1. Article 17 (4) of the Principal Regulations, as amended by Article 3 of the Public Service Vehicles (Amendment) Regulations, 1947 (b), is hereby revoked and the following Article shall be substituted therefor

"(4) An omnibus may carry a number of standing passengers not exceeding one-third of the number of passengers for which the vehicle; or in the case of a double-decked vehicle the lower deck, has seating capacity, or eight, whichever number is the less, if the standing passengers are taken up during hours of peak traffic or in circumstances in which undue hardship would be caused to such passengers if they were not carried in the vehicle:

Provided that no standing passengers shall be carried—

- (a) on the upper deck of a double-decked omnibus;
- (b) if there is any vacant seat in the vehicle."
- These Regulations shall come into operation on the 1st day of 1948, and may be cited as the Public Service Vehicles (Amendment) Regulations, 1948.

1948. No. 140

The Ministry of Commerce in exercise of the powers vested in it by the Motor Vehicles and Road Traffic Acts (Northern Ireland), 1926 to 1945, and of all other powers thereunto enabling it, hereby makes the following regulations, that is to say:-

- These Regulations may be cited as the Public Service Vehicles and Goods Vehicles (Drivers' Hours of Duty) (Amendment) Regulations, 1948, and shall be read and construed as one with The Public Service Vehicles and Goods Vehicles (Drivers' Hours of Duty) Regulations, 1935 (a) (hereinafter referred to as "the principal regulations").
- The Public Service Vehicles and Goods Vehicles (Drivers' Hours of Duty) (Amendment) Regulations, 1937 (b), are hereby revoked.
- The following proviso shall be added to Article 6 of the principal regulations:
 - "Provided, however, that the provisions contained in this Article shall not be construed as applying to :-
