

- (2) Subject to the conditions prescribed in (1) above, the order of merit in respect of each training college will be determined as follows :—

Men Candidates : By the addition of the marks obtained in the Senior Certificate Examination in —

- (a) English ;
- (b) A Mathematical subject ; and
- (c) any other four subjects of the examination (except subsidiary language subjects) not more than three of which may be Mathematical subjects.

Women Candidates : By the addition of the marks obtained in the Senior Certificate Examination in —

- (a) English ; and
- (b) any other five subjects of the examination (except subsidiary language subjects) not more than four of which may be Mathematical subjects.

B. *Special Entry Candidates.*

To be eligible for admission to training a candidate in the Special Entry category must pass the tests in General Suitability and Medical Fitness in addition to satisfying the conditions laid down in Article 4 (b) of these Regulations.

Training Colleges (Grant Conditions)

REGULATIONS, DATED 27TH AUGUST, 1948, MADE BY THE MINISTRY OF EDUCATION, NORTHERN IRELAND, UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947.

1948. No. 257

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 59 and 112 of the Education Act (Northern Ireland), 1947; (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf, hereby makes the following Regulations.

1.—(1) These Regulations may be cited as the Training Colleges (Grant Conditions) Regulations (Northern Ireland), 1948.

(2) These Regulations shall come into operation on 1st September, 1948.

2.—(1) In these Regulations, unless the context otherwise requires, the following expressions shall have the meanings hereby assigned to them, that is to say —

"college" means a training college, department or other institution for the training of teachers ;

"teacher" means a member of the teaching staff of a college including the principal ;

"training college year" means a year ending on 31st August, or on such other date as may be approved by the Ministry ;

"voluntary college" means a college not under the management of the Ministry or of a local education authority.

(2) Other expressions to which meanings have been assigned by the Act shall, for the purpose of these Regulations, have the same respective meanings.

3. These Regulations prescribe the conditions to be satisfied by a college in order that it may be grant-aided by the Ministry under Section 59 of the Act.

Management

4. A college shall be managed in a manner satisfactory to the Ministry.

Premises

5. The premises of a college shall be adequate and suitable for the purposes for which they are used.

Curriculum

6. The curriculum provided in a college shall be subject to the approval of the Ministry.

Staffing

7. A college shall be adequately staffed with suitably qualified teachers and the appointment of each teacher shall be subject to the approval of the Ministry.

8. Each full-time teacher of a college shall satisfy the Ministry of his health and physical capacity for teaching.

9.—(1) Each full-time teacher of a college shall be remunerated in accordance with such scales of salary and allowances as may be prescribed from time to time by the Ministry.

(2) Each part-time teacher of a college shall be remunerated at such rate as may be approved by the Ministry.

Admission of Students

10. The students admitted to a college shall have reached an educational standard satisfactory to the Ministry and shall be selected in accordance with arrangements approved by the Ministry.

Inspection

11. A college shall be open at all reasonable times to inspection by inspectors or other officers of the Ministry.

Submission of Accounts

12. A statement of the accounts of a voluntary college in respect of each training college year shall be prepared and furnished to the Ministry in such form and at such times as the Ministry may direct and

shall be supported by such vouchers and other evidence as the Ministry may require.

Fees

13. The tuition and any other fees to be charged to students by a college shall be subject to the approval of the Ministry.

Annual Capitation Grant

14. The Ministry, with the approval of the Ministry of Finance, may pay to the authorities of a college an annual grant in respect of each student of the college who holds a Training Scholarship under the Training Colleges (Scholarships) Regulations (Northern Ireland), 1948.

15. The Public Elementary Education (Training College Grants) Regulations, 1924, are hereby repealed.

16. The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations as it applies for the purpose of the interpretation of an Act of the Parliament of Northern Ireland.

REGULATIONS, DATED 30TH MARCH, 1948, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACT (NORTHERN IRELAND) 1947, AND UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939, AS AMENDED BY THE TEACHERS' SALARIES (WAR SERVICE) (AMENDMENT) ACT (NORTHERN IRELAND), 1946, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and by Section 1 of the Teachers' Salaries (War Service) (Amendment) Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1. These Regulations may be cited as the Training College Teachers' (Salaries and Allowances) Regulations (Northern Ireland), 1948.

2. For the purposes of these Regulations unless otherwise stated or unless the context otherwise requires—
