## Housing Subsidy Order

Order, dated 30th October, 1948, made by the Ministry of Health and Local Government with the approval of the Ministry of Finance under section one of the Housing (No. 2) Act (Northern Ireland), 1946.

## 1948. No. 316

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on the Ministry by section one of the Housing (No. 2) Act (Northern Ireland), 1946, and of every other power it thereunto enabling, hereby makes the following Order:—

- 1. In the Housing Subsidy Order (Northern Ireland), 1946 (a), as amended by the Housing Subsidy Order (Northern Ireland) 1947 (b), (which provides for the number and amount of contributions payable—
  - (a) by the Ministry to a local authority under section one of the Housing Act (Northern Ireland), 1945 (in this Order referred to as "the Act of 1945");
  - (b) by a local authority to the credit of their Housing Revenue Account under section two of the Act of 1945:
  - (c) by the Ministry to the Northern Ireland Housing Trust under subsections (1) and (2) of section sixteen of the Act of 1945; or
  - (d) by the Ministry to a housing association under the said section one of the Act of 1945 as applied to housing associations by

virtue of section twelve of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946),

for the words "thirtieth day of June, nineteen hundred and forty-eight" where they appear in the said Order there shall be substituted the words "thirtieth day of June, nineteen hundred and forty-nine", and for the first paragraph of Article 8 of the said Order there shall be substituted the following paragraph:—

- "Subject to the provisions of this Article, the Ministry shall in pursuance of section sixteen of the Act of 1945 pay to the Northern Ireland Housing Trust (in this Article referred to as "the Trust") in respect of any house, hostel or flat provided by the Trust contributions equivalent to the sum of the contributions which would have been payable to and by the local authority for the area under the foregoing provisions of this Order if the house, hostel or flat, as the case may be, had been provided by that local authority."
- 2. The Interpretation Act, 1921, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.
- 3. This Order may be cited as the Housing Subsidy Order (Northern Ireland), 1948.
