### Approved Societies Regulations (Northern Ireland), 1948

Regulations, dated 22nd March, 1948, made by the National Insurance Joint Authority, in conjunction with the Ministry of Finance, under the National Insurance Act (Northern Ireland), 1946.

### 1948 No. 92

The National Insurance Joint Authority, acting in conjunction with the Ministry of Finance, in exercise of the powers conferred by section 66 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling them in that behalf, hereby make the following regulations :—

Citation, 1.—(1) These regulations may be cited as the National Insurance commencement and in- (Approved Societies) Regulations (Northern Ireland), 1948, and shall terpretation. come into operation on the 25th March, 1948.

(2) In these regulations, unless the context otherwise requires—
"the Act" means the National Insurance Act (Northern Ireland), 1946;

" the Insurance Act " means the National Health Insurance Act, 1936;

" the Ministry " means the Ministry of Labour and National Insurance ;

" society " means an approved society ;

" branch " means a branch for the purposes of the Insurance Act ;

and other expressions have the same meanings as in the Insurance Act.

(3) References in these regulations to any enactment, regulations or rules shall include references to such enactment, regulations or rules as amended by any subsequent enactment, regulations, rules or order.

(4) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(2) Any such arrangement may relate to all or any of such benefits in respect of all or any of the insured members or persons who have ceased to be insured members or persons claiming through such members or persons, and may provide for notices and evidence of incapacity and claims for maternity benefit to be submitted by such members or persons to the Ministry and not to the society or branch, and for the payment of benefit to such members or persons to be made by and through the Ministry.

At any time after making any such arrangement as is referred to Date of in paragraph (1) of the foregoing regulation the Ministry may give operation of directions to the society or branch of a society concerned that the rangements. arrangement shall come into operation either in whole or in part as from such date or dates as may be specified in the directions, and thereafter the benefits under the Insurance Act to which the arrangement (or, as the case may be, that part of the arrangement which is in operation) relates shall not be administered otherwise than in accordance with the provisions of the arrangement.

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance so far as relates to matters with regard to which the Ministry of Finance has so directed, in exercise of powers conferred by sections I and 8 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations:—
