REGULATIONS DATED 19TH JANUARY, 1949, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1949. No. 12

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Section 77 of the Education Act (Northern Ireland), 1947, and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the State Exhibitions (Amendment) Regulations (Northern Ireland), 1949, and shall be construed as one with the State Exhibitions Regulations (Northern Ireland), 1948 (hereinafter referred to as "the Principal Regulations").
- 2. The Principal Regulations shall have effect subject to the following provisions of these Regulations.
- 3. For Regulation 5 of the Principal Regulations there shall be substituted the following Regulation:—

- "5. (1) An Exhibition shall be tenable at a University and in respect of a course of study approved by the Ministry and shall, subject to the satisfactory conduct and progress of the holder, be continued for such time, not exceeding four years, as may be necessary to enable the holder to complete the course of study in respect of which the award is made.
 - (2) An applicant to whom an Exhibition has been awarded shall enter upon the approved course of study in the year in which the award is made or, if the Ministry so approves, in a later year."
- 4. The Secondary School Examinations Regulations as amended by subsequent Regulations are hereby repealed.
 - 5. These Regulations shall come into operation on the date hereof.
