(b) references to the Family Allowances Act (Northern Ireland), 1945, shall be construed as including references to the Family Allowances (Isle of Man) Act, 1946;

(c) references to the Industrial Injuries Act shall be construed as including references to the National Insurance (Industrial Injuries) (Isle of Man)

Act, 1948;

(d) references to the Ministry shall be construed as including references to the Isle of Man Board of Social Services constituted under the Isle of Man

Board of Social Services Act, 1948;

(e) references to the Northern Ireland National Insurance Fund shall be construed as including references to the Manx National Insurance Fund;

(f) references to contributions shall be construed as including references to

contributions under the Isle of Man Act; and

(g) references to insured persons, employed persons, benefit, beneficiaries, insurance stamps, insurance cards and regulations shall be construed as including references to insured persons, employed persons, benefit, beneficiaries, insurance stamps, insurance cards and regulations respectively within the meaning of the Isle of Man Act.

- 2. The words "or within such longer period as the Ministry may in the special circumstances of any particular case allow" shall be added at the end of sub-paragraph (b) (ii) of paragraph (2) of regulation 3 and at the end of paragraph (2) of regulation 4 of the principal regulations.

2. In paragraph (1) of regulation 16 of the principal regulations, the date "1st August, 1950" shall be substituted for the date "1st August, 1949".
