REGULATIONS, DATED 30TH JULY, 1949, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance, in exercise of the powers conferred by section 62 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations :—

Citation and commencement

1. These regulations, which may be cited as the National Insurance (Unemployment Benefit) (Transitional) Amendment Regulations (No. 2) (Northern Ireland), 1949, shall be read as one with the National Insurance (Unemployment Benefit) (Transitional) Regulations (Northern Ireland), 1948 (hereinafter referred to as "the principal regulations") and shall come into operation on the 30th July, 1949.

Amendment of the principal regulations

2. In paragraph (1) of regulation 18 of the principal regulations, the date "1st August, 1950" shall be substituted for the date "1st August, 1949".

Unemployment and Sickness Benefit Amendment Regulations (Northern Ireland), 1949

REGULATIONS, DATED 31ST OCTOBER, 1949, MADE BY THE NATIONAL INSURANCE JOINT AUTHORITY UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

1949. No. 197

The National Insurance Joint Authority, in exercise of the powers conferred by section 10 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling them in that behalf, hereby make the following regulations:—

Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Unemployment and Sickness Benefit) Amendment Regulations (Northern Ireland), 1949, shall be read as one with the National Insurance (Unemployment and Sickness Benefit) Regulations (Northern Ireland), 1948 (hereinafter referred to as “the principal regulations”) and shall come into operation on the 1st November, 1949.

Amendment of the principal regulations

2.—(1) The following regulation shall be added after regulation 3 of the principal regulations:—

“3A. A person who at the commencement of any day is or thereafter on that day becomes incapable of work by reason of
