#### DESTRUCTIVE INSECTS AND PESTS

" (2.) Every drug in the actual custody of a person authorised by virtue of this Regulation shall, except when the necessities of the practice of the profession, function or employment by virtue of which that person is authorised as aforesaid otherwise require, be kept in a locked receptacle which can be opened only by him or by some other person authorised by virtue of this Regulation."

3. In paragraph (a) of Regulation 6 of the principal Regulations (which provides that every person authorised to supply raw opium and certain other substances shall keep a register, and requires the entry of certain particulars in the register) after the words "and enter therein" there shall be inserted the words "in chronological sequence."

4. These Regulations may be cited as the Raw Opium Regulations (Northern Ireland), 1949, and shall come into operation on the first day of June, 1949.

2. The Black Scab in Potatoes (Northern Ireland) Consolidation Order, 1930, shall be read and have effect as if the following were included in the Sixth Schedule thereto (Additional Districts in which the growing and planting of potatoes are restricted):

Ballykelly), Edenmore, Farlow, Glebe (E.D. Ballykelly), Killane, Lisnakilly, Lomond, Moneyrannell, Mulkeeragh (E.D. Ballykelly), Mullagh, Myroe Level, Newtown Limavady alias Rathbrady Beg, Rascahan, Rathbrady More, Shanreagh, Tamlaght (E.D. Ballykelly), Terrydremont North, Terrydremont South, Tully, Tullyhoe, all in the Barony of Keenaght, in the Administrative County of Londonderry.
