ORDER, DATED 20TH DAY OF OCTOBER, 1949, MADE BY THE REGISTRAR GENERAL, WITH THE CONSENT OF THE GOVERNOR OF NORTHERN IRELAND, UNDER SECTION 34 OF THE BIRTHS AND DEATHS REGISTRATION ACT (IRELAND), 1880.

WHEREAS under section 34 of the Births and Deaths Registration Act (Ireland), 1880, (hereinafter referred to as "the Act of 1880")

as the same applies in Northern Ireland, the Registrar General may with the consent of the Governor of Northern Ireland by order alter from time to time all or any of the forms contained in the schedules to the Registration of Births and Deaths (Ireland) Act, 1863, (hereinafter referred to as " the principal Act ") and the Act of 1880, or in any order under the said section 34, in such manner as may appear to them best for carrying into effect the principal Act :

AND WHEREAS it is expedient to alter the form of medical certificate of cause of death as approved pursuant to section 34 of the Act of 1880 by the Governor of Northern Ireland on the twenty-third day of September, 1939 :

NOW, THEREFORE, I, the Registrar General of Births, Deaths and Marriages for Northern Ireland, do hereby order as follows :—

1. The form of medical certificate of cause of death approved as aforesaid shall be altered to the form in the Schedule to this Order annexed.

2. This Order may be cited as the Registration of Births and Deaths (Forms) Order (Northern Ireland), 1949, and shall come into operation on the first day of January, 1950.

BORROWING (CONTROL AND GUARANTEE)

Control of Borrowing

THE CONTROL OF BORROWING (AMENDMENT OF EXEMPTION) ORDER (NORTHERN IRELAND), 1949, DATED 21ST OF MAY, 1949, MADE BY THE MINISTRY OF FINANCE UNDER SECTIONS TWO AND THREE OF THE LOANS GUARANTEE AND BORROWING REGULATION ACT (NORTHERN IRELAND), 1946.

1949. No. 85

WHEREAS by Article 8 of the Control of Borrowing Order (Northern Ireland), 1947, made by the Ministry of Finance under section two of the Loans Guarantee and Borrowing Regulation Act (Northern Ireland), 1946, certain exemption is granted from the provisions of Part I of that Order (which regulates, *inter alia*, the issue of securities by bodies corporate) ;

AND WHEREAS it is provided by paragraph (3) of the said Article 8 that the said exemption shall not apply to any issue of securities, if the purposes or effects of the transaction consist of or include the capitalisation of profits or reserves ;

AND WHEREAS it is provided by sub-section (2) of section three of the said Act that an Order made under the said Act may be varied or revoked by a subsequent Order ;

AND WHEREAS it is expedient that the said Order should be varied in manner hereinafter appearing :

NOW, THEREFORE, the Ministry of Finance, in pursuance of its powers under section two and sub-section (2) of section three of the Loans Guarantee and Borrowing Regulation Act (Northern Ireland), 1946, and of every other power it thereunto enabling, hereby makes the following Order :—

1. Article 8 of the Control of Borrowing Order (Northern Ireland) 1947, shall have effect as if paragraph (3) thereof were omitted therefrom.

2. The Interpretation Act, 1889, shall apply to the interpretation of this Order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

3. This Order may be cited as the Control of Borrowing (Amendment of Exemption) Order (Northern Ireland), 1949, and shall come into force on the 31st day of May, 1949.

WHEREAS the Chartered and Other Bodies (Temporary Provisions) Act (Northern Ireland), 1940 (hereinafter referred to as "the Act") makes provision for promoting economy and efficiency in the carrying on under emergency conditions of the work of certain chartered and other bodies ; for enabling the Queen's University of Belfast to adapt itself to emergency conditions ; and for purposes connected with the matters aforesaid :
