REGULATIONS, DATED 12TH JANUARY, 1949, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

1949. No. 5

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by paragraph (e) of sub-section (2) of section eleven and of sub-paragraph (a) of paragraph 4 of Part IV of the First Schedule to the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations, that is to say:—

1.—(1) These Regulations may be cited as the Health Services (Dental Estimates Committee) (Fees) Regulations (Northern Ireland), 1949, and shall have effect as from the fifth day of July, 1948.

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2.—(1) The Northern Ireland General Health Services Board may pay to the Chairman of the Northern Ireland Dental Estimates Committee as remuneration for his services a fee of £5 5s. 0d., in respect of each attendance for a period of not less than two hours at a meeting of the said Committee held for the purpose of carrying out such duties as may be prescribed with respect to the approval of estimates of dental treatment and appliances.

(2) The Northern Ireland General Health Services Board may pay to each member (other than the Chairman) of the Northern Ireland Dental Estimates Committee who is a registered dental practitioner as remuneration for his services a fee of £4 4s. 0d. in respect of each attendance for a period of not less than two hours at a meeting of the said Committee held for the purpose of carrying out such duties as may be prescribed with respect to the approval of estimates of dental treatment and appliances.

(3) Payment of the fees provided for in these Regulations may not be made to any member of the Northern Ireland Dental Estimates Committee who is a member of either House of Parliament.

REGULATIONS, DATED 10TH MAY, 1949, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government for Northern Ireland (in these Regulations referred to as "the Ministry"), in exercise of the powers conferred on it by Sections 11, 74 and 75 of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations:—

1. These Regulations may be cited as the Health Services (General Dental Services) (Amendment) Regulations (Northern Ireland), 1949.

2.—(1) In these Regulations "the Principal Regulations" means the Health Services (General Dental Services) Regulations (Northern Ireland), 1948 (a), and "the Fees Regulations" means the Health Services (General Dental Services Fees) Regulations (Northern Ireland), 1948 (b).

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

3. The Principal Regulations shall be amended in manner following:—
