

*Short Title and Commencement and Construction*

1. This Order may be cited as the Importation of Plants (Amendment) (Northern Ireland) Order, 1949, and shall come into operation on the thirtieth day of November, nineteen hundred and forty-nine, and shall be read as one with the Importation of Plants (Northern Ireland) Order, 1947 (hereinafter referred to as "the principal Order") and the principal Order and this Order may be cited together as the Importation of Plants (Northern Ireland) Orders of 1947 and 1949.

*Amendment of Article 7 of the Principal Order and the Second Schedule thereto*

2.—(1) Paragraph (4) of Article 7 of the principal Order shall be amended by adding the words "the genus *Castanea*, the genus *Populus*" after the words "the genus *Ulmus*".

(2) The additional statement in the Second Schedule of the principal Order to be given for all consignments except those consisting wholly of potatoes shall be amended to read:—

"It is further certified that the consignment does not contain any plant of the genus *Ulmus*, the genus *Castanea*, the genus *Populus* or of the genera of the order Pinaceae, viz., *Abies*, *Larix*, *Picea*, *Pinus*, *Pseudotsuga*, *Sequoia*, *Thuja* and *Tsuga*, or any plant of sugar beet or mangold (*Beta vulgaris* LINN) or any chrysanthemum plant".

*Revocation of Article 7 (6) of the Principal Order*

3. Paragraph (6) of Article 7 of the principal Order shall be revoked.

REGULATIONS MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 1 (1) OF THE DEVELOPMENT LOANS ACT (NORTHERN IRELAND), 1945, PRESCRIBING SCHEMES FOR THE ISSUE OF AGRICULTURAL DEVELOPMENT LOANS IN ACCORDANCE WITH PART I OF THE SCHEDULE TO THE ACT.

WHEREAS it is provided by sub-section (1) of section one of the Development Loans Act (Northern Ireland), 1945, (hereinafter referred

to as " the Act ") that the Ministry of Agriculture (hereinafter referred to as " the Ministry ") may with the approval of the Ministry of Finance prescribe schemes for the issue from the Agricultural Loans Fund established under the Act of agricultural development loans for purposes specified in Part I of the Schedule to the Act :

NOW, THEREFORE, the Ministry, in exercise of the powers contained in the Act, and of all other powers thereunto enabling hereby prescribes that as from the date of these Regulations, loans may be issued from the Agricultural Loans Fund for the purposes, to the persons, and under the conditions prescribed in the Schedule to these Regulations :—

1. These Regulations may be cited as the Agricultural Development Loans Regulations (Northern Ireland), 1949.

The Ministry of Finance hereby approves the loans scheme prescribed under these Regulations and the Schedule thereto, subject to the following provisos :—

- (1) Loans may not be issued on personal security only.
- (2) The amount of the loan may not exceed 75 per cent of the cost of the approved works.
- (3) A loan exceeding £2,000 in amount may not be issued without the special sanction of the Ministry of Finance.
- (4) Legal expenses and stamp duties incurred in connection with the preparation of any instrument providing security for a loan shall be paid by the borrower.

### Industries Development Loans — Transfer

ORDER MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 (1) OF THE INDUSTRIES DEVELOPMENT (AMENDMENT) ACT (NORTHERN IRELAND), 1948, TRANSFERRING TO THE MINISTRY OF COMMERCE CERTAIN INDUSTRIES DEVELOPMENT LOANS.

WHEREAS it is provided by sub-section 1 of section 3 of the Industries Development (Amendment) Act (Northern Ireland), 1948 (hereinafter referred to as "the Act"), that the Ministry of Finance may from time to time by Order transfer to the Ministry of Commerce, any loan or class of Industries Development loans issued (whether from the Government Loans Fund or from moneys provided by Parliament) before the passing of the Act under any of the provisions of the New Industries (Development) Acts (Northern Ireland), 1937 and 1944, or of the Industries Development Act (Northern Ireland), 1945.

NOW, THEREFORE, in the exercise of these powers, and of all other powers it thereunto enabling, the Ministry of Finance hereby directs and orders as follows :—

1. As from the date of this Order the classes of Industries Development loans as set out in the Schedule hereto shall be transferred to the Ministry of Commerce, and the provisions of section three of the Act, so far as they are applicable, shall apply thereto.

2. This Order may be cited as the Industries Development Loans Transfer Order (Northern Ireland), 1949.
