

- (ii) the earnings derived therefrom, in respect of that day, do not exceed three shillings and fourpence, or where the earnings are earned in respect of a period longer than a day, the earnings do not on the daily average exceed that amount."

REGULATIONS, DATED 13TH APRIL, 1949, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NORTHERN IRELAND), 1946.

1949. No. 73

The Industrial Injuries Joint Authority, in exercise of the powers conferred by section 14(5) of the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946, and of all other powers enabling them in that behalf, hereby make the following regulations :—

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Benefit) Amendment Regulations (Northern Ireland), 1949, shall be read as one with the National Insurance (Industrial Injuries) Benefit Regulations (Northern Ireland), 1948, as amended (hereinafter referred to as "the principal regulations"), and shall come into operation forthwith.

2. The following paragraph shall be substituted for paragraph (1) of regulation 5 of the principal regulations (which regulation relates to payments in respect of special hardship where the beneficiary is entitled to a gratuity)—

- “ (1) Where in any case a beneficiary is entitled to or has received a disablement gratuity, such beneficiary shall as respects that gratuity have the like rights to payments in respect of special hardship as he would have had by way of increase of disablement pension under section 14 of the Act if the disablement gratuity had been a disablement pension payable during the period taken into account by the assessment.”

Inspectors' Powers Regulations (Northern Ireland), 1949

REGULATIONS, DATED 24TH JANUARY, 1949, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE UNDER THE NATIONAL INSURANCE ACTS (NORTHERN IRELAND), 1946 AND 1948.

1949. No. 17

The Ministry of Labour and National Insurance, in exercise of the powers conferred by sections 7 (1) (a) and 47 (2) (d) of the National Insurance Act (Northern Ireland), 1946; and sections 60 (2) (d) and 63 (1) of the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations :—

1.—(1) These regulations may be cited as the National Insurance and Industrial Injuries (Inspectors' Powers) Regulations (Northern Ireland), 1949, and shall come into operation on the 1st February, 1949.

(2) In these regulations, unless the context otherwise requires —
“ the Act ” means the National Insurance Act (Northern Ireland), 1946 ;

“ the Industrial Injuries Act ” means the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946 ;

“ the Acts ” means the National Insurance Acts (Northern Ireland), 1946 and 1948 ;

“ the Ministry ” means the Ministry of Labour and National Insurance for Northern Ireland ;

“ insured person ” means an insured person under the Act or the Industrial Injuries Act, and includes a person in respect of whom (although not insured) contributions are payable by an employer ;

“ contributions ” means contributions under the Act or the Industrial Injuries Act ;
