WHEREAS by Section 4 (1) of the Health Services Act (Northern Ireland), 1948 (in this Order referred to as "the Act"), it is provided that the Minister of Health and Local Government shall by order constitute, in accordance with the First Schedule to the Act, a body to be called the Northern Ireland General Health Services Board:

REGULATIONS, DATED 26TH APRIL, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

1950. No. 66

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by Sections 75 and 80 of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations, that is to say:—

- 1.—(1) These Regulations may be cited as the Health Services (Availability of Services) Regulations (Northern Ireland), 1950.
- (2) The Interpretation Act, 1921 shall apply for the purpose of the interpretation of these Regulations in like manner as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. In these Regulations, unless the context otherwise requires, the following expressions have the meanings hereby assigned to them:—
 - "the Act" means the Health Services Act (Northern Ireland), 1948:
 - "the Board" means the Northern Ireland General Health Services Board;
 - 'General Dental Services' means the services provided under the arrangements made by the Board in pursuance of subsection (1) of Section 11 of the Act;
 - "General Medical Services" means the services provided under the arrangements made by the Board in pursuance of sub-section (1) of Section 6 of the Act;
 - "Pharmaceutical Services" means the services provided under the arrangements made by the Board in pursuance of subsection (1) of Section 12 of the Act;
 - "Supplementary Eye Services" means the services provided under the arrangements made by the Northern Ireland Hospitals Authority in pursuance of sub-section (1) of Section 22 of the Act
