Order, dated 25th August, 1950, made by the Ministry of Health and Local Government under the Mental Health Act (Northern Ireland), 1948.

1950. No. 148

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), in exercise of the powers conferred on it by the Mental Health Act (Northern Ireland), 1948 (in this Order referred to as "the Act") and of all other powers enabling it in that behalf, hereby orders as follows:—

- 1.—(1) This Order may be cited as the Mental Health (Institutions) Order (Northern Ireland), 1950.
- (2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of this Order in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

- 2. The Ministry approves of the use of the hospitals and the welfare hostel specified in the first column of the Schedule hereto, to the extent specified in the third column of the Schedule, as institutions, for the purposes of Part III of the Act.
- 3. The Mental Health (Institutions) Order (Northern Ireland), 1949, (a) is hereby revoked.
