## Housing Subsidy Order

Order,\* dated 15th August, 1950, made by the Ministry of Health and Local Government, with the approval of the Ministry of Finance under section one of the Housing (No. 2) Act (Northern Ireland), 1946.

## 1950. No. 192

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on the Ministry by section one of the Housing (No. 2) Act (Northern Ireland), 1946, and of every other power it thereunto enabling, hereby makes the following Order :---

1. In the Housing Subsidy Order (Northern Ireland), 1946 (a), as amended by the Housing Subsidy Order (Northern Ireland), 1947 (b), the Housing Subsidy Order (Northern Ireland), 1948 (c), and the Housing Subsidy Order (Northern Ireland), 1949 (d), (which provides for the number and amount of contributions payable —

- (a) by the Ministry to a local authority under section one of the Housing Act (Northern Ireland), 1945 (in this Order referred to as " the Act of 1945 ");
- (b) by a local authority to the credit of their Housing Revenue Account under section two of the Act of 1945;
- (c) by the Ministry to the Northern Ireland Housing Trust under subsections (1) and (2) of section sixteen of the Act of 1945; or
- (d) by the Ministry to a housing association under the said section one of the Act of 1945 as applied to housing associations by virtue of section twelve of the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946),

for the words "thirtieth day of June, nineteen hundred and fifty" where they appear in the said Order there shall be substituted the words "thirtieth day of June, nineteen hundred and fifty-one".

2. The Interpretation Act, 1921, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

#### INTOXICATING LIQUOR

#### Compensation : Charges in respect of Licences

ORDER, DATED STH JUNE, 1950, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE INTOXICATING LIQUOR ACT (NORTHERN IRELAND) 1923, AS AMENDED BY THE INTOXICATING LIQUOR (FIN-ANCE) ACT (NORTHERN IRELAND), 1925, AND BY THE EXCHEQUER AND FINANCIAL PROVISIONS (NO. 2) ACT (NORTHERN IRELAND), 1936.

## 1950. No. 88

1. In pursuance of sub-sections (3) (b) and (4) of section three of the Intoxicating Liquor Act (Northern Ireland) 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936, the Ministry of Finance hereby prescribes that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending the 30th day of September, 1951, shall be fourteen shillings and tenpence for each pound sterling of the maximum rates of charge authorised by sub-section (1) of section one of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

2. This Order may be cited as the Intoxicating Liquor (Compensation Charges) Order (Northern Ireland), 1950.
