(89)") dated the 4th day of April, 1949, as amended by the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 1) Order, 1949 (b) dated the 13th day of June, 1949, the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 4) Order, 1949 (c) dated the 27th day of July, 1949 and the Baking Wages Council (Northern Ireland) Wages Regulation (Amendment) (No. 5) Order, 1949 (d) dated the 24th day of November, 1949, which fixes the minimum remuneration to be paid to certain workers in relation to whom the Baking Wages Council (Northern Ireland) operates;

1. As from the specified date Order N.I.Bk. (89) as amended shall Statutory have effect subject to the further amendment set out in the Schedule minimum remuneration.

2. In this Order the expression "the specified date" means the Commence-6th day of January, 1950. Provided that where, as respects any ment. worker who is paid wages at intervals not exceeding seven days, that date does not correspond with the beginning of the period for which the wages are paid, the expression "the specified date" means, as respects that worker, the beginning of the next such period following that date.
