- 4. In determining the point at which an existing member shall enter the scale of pay in this Schedule prescribed for her rank, credit shall be given to her for past service in that rank by reckoning it for purposes of increments.
- 5. Notwithstanding the provisions of Section 2 of the Constabulary and Police (Ireland) Act, 1883, no deduction in respect of barrack accommodation shall be made from the pay prescribed in this Schedule.
- 6. Where a Constable who has resigned from the force, subsequently rejoins it, the Inspector General may, if he so thinks fit, allow the period which at the date of her resignation had been credited to her for the purpose of pay to be, in whole or in part, similarly credited to her for purposes of pay on her rejoining the force.

7. Where, within the meaning of the Royal Ulster Constabulary Pensions Order, 1949, a regular policewoman in Great Britain has transferred to the force, she shall be entitled to reckon for purposes of pay in the rank in which she joins the force all service in the same rank which, at the date of the transfer, she was entitled to reckon for purposes of pay in the force from which she transferred.

Now, THEREFORE, I, WILLIAM SPENCER, EARL GRANVILLE, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by paragraph (a) of sub-section (3) of section thirteen of the Ryegrass Seed (Temporary Provisions) Act (Northern Ireland), 1949, do hereby order and direct that the said Act be continued in force until the thirty-first day of July, nineteen hundred and fifty-one.
