Grants in respect of private houses and houses for letting

Order,* dated 19th April, 1950, made by the Ministry of Health and Local Government, with the approval of the Ministry of Finance, under section fifteen of the Housing (No. 2) Act (Northern Ireland), 1946.

The Ministry of Health and Local Government for Northern Ireland (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance for Northern Ireland, in exercise of the powers conferred on the Ministry by section fifteen of the Housing (No. 2) Act (Northern Ireland), 1946, (in these Regulations referred to as "the No. 2 Act of 1946") and of every other power it thereunto enabling, hereby makes the following Order:—

Contributions and Grants

1. The Housing (Grants) Order (Northern Ireland), 1947 (a), (as amended by the Housing (Grants) Order (Northern Ireland), 1948 (b), and the Housing (Grants) Order (Northern Ireland), 1949 (c)), shall have effect as if for the words "thirtieth day of June, nineteen hundred and fifty" in Articles 1 and 2 of the said Order, there were substituted the words "thirtieth day of June, nineteen hundred and fifty-one."

Interpretation

2. The Interpretation Act, 1921, shall apply to the interpretation of this Order in like manner as it applies to the interpretation of an Act of Parliament.

Citation

3. This Order may be cited as the Housing (Grants) Order (Northern Ireland), 1950, and shall, subject to the provisions of sub-section

Schemes for the Erection of Houses (for letting) by Private Persons

REGULATIONS, DATED 5TH JUNE, 1950, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HOUSING AND LOCAL GOVERNMENT (MISCELLANEOUS PROVISIONS) ACT (NORTHERN IRELAND), 1946, AS AMENDED BY THE HOUSING (NO. 2) ACT (NORTHERN IRELAND), 1946.

The Ministry of Health and Local Government, in exercise of the powers conferred upon it by the Housing and Local Government (Miscellaneous Provisions) Act (Northern Ireland), 1946, as amended by the Housing (No. 2) Act (Northern Ireland), 1946, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Housing (Houses built for Letting) (Amendment) Regulations (Northern Ireland), 1950, and shall be construed as one with the Housing (Houses built for Letting) Regulations (Northern Ireland), 1946 (in these Regulations referred to as "the Principal Regulations") (a).
- (2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. For Schedules II, III, IV and V to the Principal Regulations there shall be substituted the Schedules to these Regulations.
