Adoption of Children : Duties of Registrars

REGULATIONS, DATED 1ST JUNE, 1950, MADE BY THE REGISTRAR-GENERAL UNDER THE BIRTHS AND DEATHS REGISTRATION ACTS, (NORTHERN IRELAND), 1863 TO 1947, AS APPLIED BY SUB-SECTION (12) OF SECTION 14 OF THE ADOPTION OF CHILDREN ACT (NORTHERN IRELAND), 1950.

The Registrar-General for Northern Ireland, in exercise of the powers conferred on him by the Births and Deaths Registration Acts (Northern Ireland), 1863 to 1947, as applied by sub-section (12) of Section 14 of the Adoption of Children Act (Northern Ireland), 1950, and with the approbation of the Governor of Northern Ireland, hereby makes the following Regulations :—

1. These Regulations may be cited as the Adoption of Children (Duties of Registrars) Regulations (Northern Ireland), 1950, and shall come into operation on the date hereof.

2. The superintendent registrar or registrar having the custody of the register containing the entry of the birth of an adopted child shall, on being so directed by the Registrar-General, write in the margin of the entry the word " Adopted ", with his signature and official description, and shall forthwith prepare and send to the Registrar-General a certified copy of the entry, including the marginal addition.

3. The superintendent registrar or registrar having the custody of the register containing an entry of birth which has been marked " Adopted " in pursuance of Regulation 2 hereof shall, on receiving information from the Registrar-General that the adoption order made in respect of the person to whom the entry relates has been quashed or that an appeal against it has been allowed, strike out the word " Adopted " and write underneath in the margin the words " Adoption cancelled " with his signature and official description. He shall then prepare and send to the Registrar-General a certified copy of the entry, including the marginal additions.

4. Where a certified copy of an entry of the birth of a person who has been adopted is issued pursuant to the Births and Deaths Registration Acts (Northern Ireland), 1863 to 1947, the certified copy shall, unless the marginal note contains the words " Adoption cancelled "

as required by Regulation 3 hereof, include a copy of the marginal note. If the marking regarding the adoption has been cancelled as aforesaid, the marginal notes regarding the adoption and the cancellation thereof shall be omitted from the certified copy.

5. The Adoption of Children (Duties of Registrars, etc.) Regulations (Northern Ireland), 1930, are hereby revoked.

Registrars' Districts of Armagh and Blackwatertown

ORDER, DATED THE 15TH DAY OF DECEMBER, 1950, MADE BY THE REGISTRAR-GENERAL UNDER SECTION 18 OF THE REGISTRATION OF BIRTHS AND DEATHS (IRELAND) ACT, 1863.

WHEREAS it is enacted by section 18 of the Registration of Births and Deaths (Ireland) Act, 1863, (as that Act applies in Northern Ireland) that in the event of the Registrar-General considering it expedient for the better execution of the Act, it shall be lawful for him to make such alterations in the boundaries of any Registrar's District as he may, subject to the approval of the Governor of Northern Ireland, deem expedient and proper :

AND WHEREAS the Registrars' Districts from time to time made under the above-mentioned Act are by virtue of section 7 of the Registration of Marriages (Ireland) Act, 1863, (as that Act applies in Northern Ireland) Registrars' Districts for the purposes of the last-mentioned Act :

AND WHEREAS the County Council of the County of Armagh has made an Order (which Order has been confirmed by the Ministry of Health and Local Government) extending the boundary of the Urban District of Armagh by the transfer thereto of an area including (inter alia) a portion of the townland of Mullynure, which townland is within the Registrar's District of Blackwatertown :

AND WHEREAS the whole of the Urban District of Armagh, with the exception of the above-mentioned portion of the townland of
