

PETROLEUM Conveyance

REGULATIONS, DATED 24TH FEBRUARY, 1950, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION SIX OF THE PETROLEUM (CONSOLIDATION) ACT (NORTHERN IRELAND), 1929.

1950. No. 31

The Minister of Home Affairs in pursuance of the powers conferred on him by Section Six of the Petroleum (Consolidation) Act (Northern Ireland), 1929, hereby makes the following Regulations :—

1. In sub-paragraph (b) of paragraph (2) of Regulation 13 of the Petroleum-Spirit (Conveyance) Regulations (Northern Ireland), 1940, as amended by the Petroleum-Spirit (Conveyance) Regulations (Northern Ireland), 1943, (which Regulation contains requirements as to attendance upon a vehicle engaged in the conveyance of petroleum-spirit by road, and provides that the driver may while present with the vehicle be regarded as a person attending it) for the words " while present with the vehicle " there shall be substituted the words " while in, or in close proximity to, the vehicle ".

2. In sub-paragraph (1) of paragraph 14 of the Schedule to the said Petroleum-Spirit (Conveyance) Regulations (Northern Ireland), 1940, (which provides that if electric lighting is employed on a vehicle used for the conveyance of petroleum-spirit by road the pressure shall not exceed sixteen volts) for the word " sixteen " there shall be substituted the word " twenty-four ".

3. These Regulations may be cited as the Petroleum-Spirit (Conveyance) Regulations (Northern Ireland), 1950, and shall come into operation on the first day of April, 1950.

ORDER IN COUNCIL, DATED 12TH JANUARY, 1950, MADE UNDER SUBSECTION (3) OF SECTION TWENTY-SIX OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND
GRANVILLE

WHEREAS sub-section (2) of section twenty-six of the Medicines,

Pharmacy and Poisons Act (Northern Ireland), 1945, (hereinafter referred to as "the Act") provides that the Council of the Pharmaceutical Society of Northern Ireland and the Medical Faculty of the Queen's University, Belfast, may from time to time, by a resolution passed by both of these bodies, declare that the Third Schedule to the Act ought to be amended by including in, or removing from, any Part thereof any substances specified in the resolution, or by transferring a substance so specified from one Part of the said Schedule to another Part :

AND WHEREAS sub-section (3) of section twenty-six of the Act provides that any resolution passed by the said bodies shall be submitted by the Minister of Home Affairs for the approval of the Governor in the Privy Council of Northern Ireland and, if so approved, the resolution and approval shall be published in the *Belfast Gazette* ; and on the expiration of one month from the date of such publication the Third Schedule to the Act shall have effect subject to the inclusion in, or exclusion from, any Part thereof of the substance specified in the resolution, or to the transference of that substance from one Part of the said Schedule to another Part (as the case may require) :

AND WHEREAS the said Council and the said Medical Faculty, by virtue of and in exercise of the powers vested in them by the said sub-section (2) of section twenty-six of the Act, did, on the 26th day of May, 1949, and on the 27th day of June, 1949, respectively, resolve and declare that the Third Schedule to the Act ought to be amended as follows :—

In Part I of the Third Schedule to the Act :—

After the item "Metopon (methyl-dihydro-morphinone) ; its salts" ; there shall be inserted the item "6-morpholino-4 ; 4-diphenylheptane-3-one ; its salts" and in the item "Dinitrocresols ; dinitronaphthols ; dinitrophenols ; dinitrothymols", the word "Dinitrocresols" shall be omitted.

In Part II of the said Third Schedule, after the item relating to "arsenical substances", there shall be inserted the word "Dinitrocresols" ; after the item relating to "Phenols" there shall be inserted the following item :—

"Phosphorus compounds, the following :—

Bis-dimethylaminophosphonous anhydride,
Diethylparanitrophenyl thiophosphate, Hexaethyl
tetraphosphate, Tetraethyl pyrophosphate".

AND WHEREAS the said resolution has been duly submitted by the Minister of Home Affairs for the approval of the Governor in the Privy Council of Northern Ireland in accordance with the provisions of the said sub-section (3) :

NOW, THEREFORE, I, WILLIAM SPENCER, EARL GRANVILLE, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Companion of the Distinguished Service Order, Vice-Admiral, Governor of Northern Ireland, by and with the consent of the Privy Council, in exercise of the powers conferred by the said sub-section (3) do hereby approve of the said resolution.

Poisons

REGULATIONS, DATED THE 24TH DAY OF AUGUST, 1950, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTIONS THIRTY AND THIRTY-TWO OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND), 1945.

1950. No. 142

I, THE RIGHT HONOURABLE BRIAN MAGINESS, K.C., Minister of Home Affairs for Northern Ireland, in pursuance of Sections thirty and thirty-two of the Medicines, Pharmacy and Poisons Act (Northern Ireland), 1945, (hereinafter referred to as "the Act") do hereby make the following Regulations:—

1. In paragraph (4) (b) of Regulation 5 of the Poisons Regulations (Northern Ireland), 1946, after the words "Registered Veterinary Surgeon" there shall be inserted the words "or Registered Veterinary Practitioner".

2. At the end of Regulation 8 of the said Regulations, which confers exemption from the provisions relating solely to substances in the First Schedule to the said Regulations, there shall be added the following words:—

" or

(e) articles containing Zinc phosphide and prepared for the destruction of rats and mice".

3. In paragraph (1) (a) (i) of Regulation 13 of the said Regulations after the words "the said term" there shall be deleted the word "or" and there shall be inserted the following sub-paragraph "(ii) the name published by the General Medical Council as the approved name of the poison; or" and sub-paragraph (1) (a) (ii) shall be numbered sub-paragraph (1) (a) (iii).
