MARKETING OF FRUIT ACT (NORTHERN IRELAND), 1931

Permit for Ungraded Fruit

M. of

is hereby granted permission to send ungraded apples from Northern Ireland to Great Britain or the Isle of Man on the following conditions :—

- (1) that the apples are in marketable condition ;
- (2) that the apples are packed in bags or such other containers as may be approved by the Ministry ;
- (3) that not more than 5 per cent. of the apples in any one container shall be equal to or above " C " standard ;
- (4) that where bags are used the weight of apples in each bag shall not exceed 1 cwt.
- (5) that each bag is clearly and indelibly labelled and each other container clearly and indelibly marked with the words " Ungraded apples for manufacture " ;
- (6) that the fruit is sent only for manufacturing purposes ;
- (7) that the number of this permit is clearly shown on each container in the consignment ;
- (8) that each consignment is accompanied by a Return or Returns of Shipment as prescribed for licence-holders in Article 4 (3) of the Rules made under the above-mentioned Act.

R U L E S

RULES, DATED THE 21ST DAY OF SEPTEMBER, 1950, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 9 OF THE MARKETING OF POULTRY ACT (NORTHERN IRELAND), 1949.

The Ministry of Agriculture in exercise of the power conferred on it by Section 9 of the Marketing of Poultry Act (Northern Ireland), 1949, and of every other power enabling it in that behalf, hereby makes the following Rules, that is to say :—

1. *Short Title.* These Rules may be cited as the Marketing of Poultry Rules (Northern Ireland), 1950.

2. *Interpretations.* In these Rules unless the context otherwise requires :—

- (1) The word " Act " shall mean the Marketing of Poultry Act (Northern Ireland), 1949.
- (2) The word " Poussin " shall mean a young domestic fowl which weighs, if alive, not less than 1½ lb. and not more than 2 lb., or if plucked, undrawn and untrussed, not less than 1 lb. and not more than 1¾ lb.
- (3) " Wet Plucking " shall mean the removal of feathers by any method which involves the immersion of the carcase in water.
- (4) " Clean Plucking " shall mean the removal of all feathers and all growth associated with feathers (whether known as " pins " or " downs " or otherwise).
- (5) " Hard Frozen " shall mean subjected to a temperature so low as to make the carcase completely rigid.
- (6) The words " Drawn and Trussed " and the abbreviation " Trussed " as applied to a grade designation of poultry shall mean with the feathers, head, shanks and all inedible offal removed, but inclusive of the giblets, and grammatical variations of these expressions shall be construed accordingly.
