

(2) The Principal Regulations which apply in respect of the admission of students to training colleges in 1952 shall have effect subject to the following provisions of these Regulations.

2. For Regulation 8 of the Principal Regulations there shall be substituted the following Regulation :—

“ 8. *Submission of Applications.* Forms of application may be obtained from the Ministry and must, except in the case of persons admitted under Regulation 6 hereof, be duly completed and returned so as to reach the Ministry not later than 1st May, 1952 :

Provided, however, that applications received from candidates other than university graduates after 1st May but not later than 1st July and applications from university graduates received after 1st May but not later than 1st September may be accepted, at the discretion of the Ministry, on payment of a fee of 10s. 0d. in respect of each application.

Nothing in this Regulation shall be regarded as extending the latest dates of application for admission to the Ministry's Grammar School Senior Certificate Examination.”

Training Colleges : Salaries and Allowances

REGULATIONS, DATED 18TH JULY, 1951, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACT (NORTHERN IRELAND), 1947, AND UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939, AS AMENDED BY THE TEACHERS' SALARIES (WAR SERVICE) (AMENDMENT) ACT (NORTHERN IRELAND), 1946, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland), 1947, and by Section 1 of the Teachers' Salaries (War Service) (Amendment) Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations :—

1. These Regulations may be cited as the "Training College Teachers (Salaries and Allowances) Regulations (Northern Ireland), 1951".

2. For the purposes of these Regulations unless otherwise stated or unless the context otherwise requires —

- (a) "the Ministry" means the Ministry of Education for Northern Ireland ;
- (b) "approved" means approved by the Ministry ;
- (c) "recognised" means recognised by the Ministry ;
- (d) "training colleges" means Stranmillis Training College and St. Mary's Training College, Belfast ;
- (e) "college authorities" means the Committee of Management of the College or other body recognised by the Ministry as being responsible for the operation of the College ;
- (f) "war service" means service as defined in Section 12 of the Teachers' Salaries and Superannuation (War Service) Act (Northern Ireland), 1939 ;
- (g) "contributory service" has the meaning assigned to it by Section 2 (1) (a) of the Teachers' Superannuation Act (Northern Ireland), 1950.

3.—(1) Subject to the provisions of these Regulations the salary scales for full-time lecturers and senior lecturers employed in recognised training colleges shall be as follows :—

LECTURERS

- MEN : From a minimum of £550 rising by annual increments of £25 to a maximum of £850 per annum.
- WOMEN : From a minimum of £500 rising by annual increments of £25 to a maximum of £750 per annum.

SENIOR LECTURERS

- MEN : From a minimum of £800 rising by annual increments of £25 to a maximum of £1,050 per annum.
- WOMEN : From a minimum of £700 rising by annual increments of £25 to a maximum of £950 per annum.

(2) The Scale salary payable to lecturers under paragraph (1) of this Regulation shall be increased by £50 in the case of lecturers who hold a first or second class honours degree of an approved university or such other qualification as the Ministry may accept as equivalent thereto.

4. The placing of lecturers and senior lecturers on the appropriate salary scale shall be made in accordance with the provisions of these Regulations and shall be subject to the approval of the Ministry.

5. In determining the placing of a person on the salary scale for lecturers, the following conditions shall be observed :—

- (a) Credit shall be given for increments to which the lecturer would be entitled on the appropriate Northern Ireland teachers' salary scale in respect of previous teaching service.
- (b) An increment of £25 shall be allowed in respect of each completed year of full-time service as a lecturer in an approved training college or university or in respect of service which is accepted by the Ministry to be of equivalent value.

6. In determining the placing of a person on the salary scale for senior lecturers, due regard shall be had to previous service of equivalent standing or to existing emoluments as a teacher and the commencing salary shall not be less than the salary to which the person would be entitled as a lecturer in a training college : provided that the number of increments to be awarded on the scales laid down in Regulation 3 of these Regulations in respect of service prior to 1st April, 1951, shall not exceed six.

7. The award of annual increments on the salary scales shall be subject to satisfactory service.

8. A person who, before or after becoming employed in contributory service, has undertaken war service, shall be entitled to have that war service reckoned for increments of salary as if it had been teaching service :

Provided that :—

- (1) war service given by a person before attaining the age of 18 years shall not be reckoned for the purpose of this Regulation ; and
- (2) a person who, before becoming employed in contributory service has undertaken war service, shall have become employed in contributory service before the 1st April, 1955.

9. The salaries of the Principals of the training colleges shall be determined by the Ministry, subject to the approval of the Ministry of Finance.

10. In addition to the appropriate scale salary determined in accordance with the provisions of these Regulations, an allowance, at such rate as may be approved by the Ministry, may be paid to a lecturer or senior lecturer in respect of special responsibilities.

11. The scales of salary prescribed in these Regulations shall remain in force until such time as they are varied by Regulations made by the Ministry after consultation with the Ministry of Finance.

12.—(1) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(2) If any question arises as to the interpretation of these Regulations, or as to whether any of the requirements thereof are fulfilled, or as to the amount of any grant payable thereunder, the decision of the Ministry shall be final.

13. The foregoing Regulations shall take and have effect as from the first day of April, 1951.

14. The Training College Teachers' (Salaries and Allowances) Regulations (Northern Ireland), 1948 as amended by subsequent Regulations are hereby revoked.

Register of Electors

REGULATIONS, DATED 24TH SEPTEMBER, 1951, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SUB-SECTION (4) OF SECTION SIXTEEN OF THE ELECTIONS AND FRANCHISE ACT (NORTHERN IRELAND), 1946, (REPRINT TO 1948).

WHEREAS by the Elections and Franchise Act (Northern Ireland), 1946 (Reprint to 1948), (hereinafter referred to as "the Act of 1946") it is, in effect, provided that a Register of Parliamentary and Local Government electors shall be published every third year and that Electoral Regulations shall be made by the Ministry of Home Affairs governing the preparation of such Registers :

AND WHEREAS it is provided by the Representation of the People Act, 1949, as amended by the Electoral Registers Act, 1949, (hereinafter jointly referred to as "the Act of 1949") that for the purposes of elections of members to the Parliament of the United Kingdom from constituencies in Northern Ireland a Register of Parliamentary electors shall be published each year :

AND WHEREAS regulations have been made by the Secretary of State under the Act of 1949 providing that in every year in which a Register is prepared under the provisions of the Act of 1946 the annual register for that year shall be combined with the first-mentioned Register :

AND WHEREAS the year 1952 is such a year :
