**Employment of Teachers (Grants in Respect of National  
Insurance Contributions)**

REGULATIONS DATED 14TH SEPTEMBER, 1951, MADE BY THE MINISTRY OF  
EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND)  
1947 TO 1951, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

1951. No. 169

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Section 104 of the

Education Act (Northern Ireland), 1947, as amended by Section I of the Education (Miscellaneous Provisions) Act (Northern Ireland), 1950, and by Section 8 of the Education (Amendment) Act (Northern Ireland), 1951, and with the approval of the Ministry of Finance, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Employment of Teachers (Grants in Respect of National Insurance Contributions) Regulations, 1951.

(2) These Regulations shall have effect as from 1st October, 1951.

2. In these Regulations unless the context otherwise requires —

“ the Act ” means the Education Act (Northern Ireland), 1947, as amended by subsequent enactments ;

“ the National Insurance Acts ” means the National Insurance Act (Northern Ireland), 1946 and the National Insurance (Industrial Injuries) Act (Northern Ireland), 1946 and includes any amendments of those Acts ;

“ school authority ” means a local education authority in the case of a school or institution under the control of such authority and in the case of a school managed by a person or persons other than a local education authority that person or those persons ;

“ school ” means a grant-aided school as defined in sub-section (2) of Section 6 of the Act ;

“ institution ” means an institution providing further education as defined in Section 39 of the Act ;

“ teacher ” means a person who with the approval of the Ministry is employed on the teaching staff of a school or institution, and in the case of a voluntary grammar school does not include a teacher who is not on the authorised staff.

3. Subject to the provisions of these Regulations and, in the case of a local education authority subject to the provisions of the Parliamentary Grants (Local Education Authorities) Regulations, 1948, as from time to time amended, the Ministry may pay to school authorities grants at the rates shown hereunder towards expenditure incurred by such authorities on the payment of employers' contributions under the National Insurance Acts in respect of full-time teachers employed by such authorities :—

<i>School Authority</i>	<i>Rate of grant towards expenditure on the payment of employer's contributions</i>
(a) A Local Education Authority	100%
(b) A school committee appointed for a voluntary primary school or a voluntary intermediate school in accordance with a scheme framed under Section 81 of the Act ...	100%
(c) The managers of a voluntary primary school or a voluntary intermediate school for which a school committee has not been appointed in accordance with a scheme framed under Section 81 of the Act ...	65%
(d) The managers of a voluntary grammar school ...	65%
(e) The managers of a nursery school or a special school not under the control of a local education authority ...	65%

4. In the case of school authorities mentioned in paragraphs (a) and (b) of Regulation 3 of these Regulations grant under the provisions of these Regulations may be made either by direct payment to school authorities, or by the payment by the Ministry, on behalf of school authorities, of the employers' share of National Insurance contributions in respect of teachers employed by such authorities.

5. Payment of grant under these Regulations in respect of the employment of any teacher shall be subject to —

- (a) the fulfilment of the conditions applicable to the payment of grant in respect of the salary of such teacher ;
- (b) the observance of the Ministry's requirements regarding the form of application for grant ; and
- (c) the furnishing of such information as the Ministry may require regarding expenditure incurred on the payment of National Insurance contributions in respect of teachers.

Provided also that where the school authority is a local education authority the expenditure directly incurred by such authority on the payment of employer's share of National Insurance contributions in respect of teachers employed by them shall be included in the expenditure in respect of which grants are payable by the Ministry to the authority under the Parliamentary Grants (Local Education Authorities) Regulations, 1948, as from time to time amended, and grant in respect of such expenditure shall be payable in accordance with the provisions of those Regulations.

6. As from the date on which these Regulations have effect the following Regulations shall be revoked :—

Employment of Teachers (National Insurance Contributions Grants) Regulations 1950, (Statutory Rules and Orders of Northern Ireland, 1950, No. 94.)
