Any provision of these regulation affecting the rights and obligations of ophthalmic opticians and dispensing opticians shall, so far as they are applicable, be deemed to form part of their respective terms of service under the arrangements made for the provision of supplementary eye services.

SCHEDULE.

CHARGES PAYABLE FOR GLASSES ETC.,

Glasses per pair	£1 0s. 0d. and the cost of the frame
Where, following a change of prescription, one lens only is supplied to the person's own glasses—	10s. 0d.

For the purpose of this Schedule the cost of a frame shall be deemed to be the sum specified in the statement of fees and charges prepared under Regulation 3 of the existing eye services regulations and for the time being in force as the sum payable therefor whether by the person supplied or by the Authority or by both of them.

REGULATIONS* DATED 6TH DECEMBER, 1951, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

The Ministry of Health and Local Government for Northern Ireland in exercise of the powers conferred on it by sections twenty-two, seventy-six and eighty of the Health Services Act (Northern Ireland), 1948, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

*A draft of these Regulations was approved by resolution of the House of Commons on the 13th day of November, 1951 and by resolution of the Senate on the 27th day of November, 1951.

1.—(1) These Regulations may be cited as the Health Services (Supplementary Eye Services) (Amendment) Regulations (Northern Ireland), 1951.

(2) The Interpretation Act, 1921 shall apply for the purpose of the interpretation of these Regulations in like manner as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. The Health Services (Supplementary Eye Services) Regulations (Northern Ireland), 1951 shall be amended in manner following:—

The following proviso shall be added to paragraph (1) of Regulation 3:—

“ Provided that where a contract or arrangement between an optician and a patient for the supply of glasses is made on or after 21st May, 1951, the provisions of this Regulation shall not apply in any case where the Authority are satisfied that a previous contract or arrangement between the said patient and another optician for the provision of the aforesaid glasses under supplementary eye services existed prior to 21st May, 1951, and that by reason of the death of the last mentioned optician, or his withdrawal or removal from the Ophthalmic List or by reason of other circumstances not within the control of the patient glasses were either not supplied or, if supplied, were, in the opinion of the Authority, unsatisfactory.”
