family but for the provisions of subsection (3) of section 24 of the Family Allowances Act (Northern Ireland), 1945 (which subsection makes presence in Northern Ireland a condition of a child's being included in a family); and

(b) the widow becomes or has become entitled to a widow's basic pension ;

a child's allowance shall be payable to the widow for any period during which the child would; but for the said subsection (3), be included in her family, at such a rate as will increase the rate of that pension to the rate below which the widowed mother's allowance, if it were payable, might not be reduced under regulation 12, on account of the earnings of the widow."

Residence and Persons Abroad Amendment Regulations (Northern Ireland), 1951

REGULATIONS, DATED 15TH FEBRUARY, 1951, MADE BY THE MINISTRY OF LABOUR AND NATIONAL INSURANCE, IN CONJUNCTION WITH THE MINISTRY OF FINANCE, UNDER THE NATIONAL INSURANCE ACT (NORTHERN IRELAND), 1946.

1951. No. 39

The Ministry of Labour and National Insurance, in conjunction with the Ministry of Finance, in exercise of the powers conferred by section 57 of the National Insurance Act (Northern Ireland), 1946, and of all other powers enabling it in that behalf, hereby makes the following regulations:—

Citation, interpretation and commencement

1. These regulations, which may be cited as the National Insurance (Residence and Persons Abroad) Amendment Regulations (Northern Ireland), 1951, shall be read as one with the National Insurance (Residence and Persons Abroad) Regulations (Northern Ireland), 1948,

Residence and Persons Abroad

as amended (hereinafter referred to as "the principal regulations") and shall come into operation on the 1st March, 1951.

Amendment of regulation 3 of the principal regulations

2. Sub-paragraph (b) (ii) of paragraph (2) of regulation 3 of the principal regulations (which provision imposes a time limit for the exercise of the option to pay certain contributions) shall be omitted.

Amendment of regulation 4 of the principal regulations

3. The following paragraph shall be substituted for paragraph (2) of regulation 4 of the principal regulations (which regulation contains special provisions for payment of contributions in respect of periods abroad by persons returning to Northern Ireland) :---

"(2) Any contributions which a person is entitled to pay under the preceding paragraph may be paid —

- (a) by a person in whose case the period between the appointed day and his return to Northern Ireland fell in three or more contribution years, at any time before the end of the fourth contribution year following the contribution year in which that period terminated; and
- (b) by a person in whose case the period between the appointed day and his return to Northern Ireland fell only in one or two contribution years, at any time before the end of the benefit year beginning next after the end of the contribution year in which that period terminated : provided that the Ministry, if it is satisfied that there is good cause for delay in making payment, may extend the time under this provision but not later than the end of the third contribution year following the contribution year in which that period terminated."
