#### **Travelling Expenses of Patients**

REGULATIONS, DATED 27TH MARCH, 1951, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER SECTION TWENTY-ONE OF THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

## 1951. No. 43

The Ministry of Health and Local Government for Northern Ireland (in these regulations referred to as "the Ministry"), in exercise of the powers conferred on it by section twenty-one of the Health Services Act (Northern Ireland), 1948, hereby makes the following regulations:—

1.—(1) These regulations may be cited as the Health Services (Travelling Expenses of Patients) (Hospital and Specialist Services) Regulations (Northern Ireland), 1951, and shall come into operation on the first day of May, 1951.

(2) The Interpretation Act, 1921 shall apply for the purpose of the interpretation of these regulations in like manner as it applies for the interpretation of an Act of the Parliament of Northern Ireland.

2. The Health Services (Travelling Expenses of Patients) (Hospital and Specialist Services) Regulations (Northern Ireland), 1948 (a) are hereby revoked.

3. Subject to the provisions of Regulation 4 of these regulations, the Northern Ireland Hospitals Authority (in these regulations referred to as "the Authority") shall, on request, pay the travelling expenses necessarily incurred or to be incurred by a person (including the travelling expenses of a companion) in attending a hospital or other place approved by the Authority for the purpose of availing himself of hospital and specialist services, if it is determined by such person or body as the Ministry may designate for the purpose that, in the circumstances of the case, the payment of such expenses by the patient would involve hardship :

Provided that :

- (a) if it is determined as aforesaid that the patient may reasonably be required to bear a part of such expenses the balance only shall be payable by the Authority; and
- (b) the travelling expenses of a companion shall not be payable by the Authority if they determine that, having regard to the age or health of the patient or other relevant circumstances, it was unnecessary for the patient to be accompanied.

4. Notwithstanding the provisions of Regulation 3 of these regulations, the Authority shall, on request, pay the travelling expenses

necessarily incurred or to be incurred by a person (including the travelling expenses of a companion) in attending a hospital or other place approved by the Authority for the purpose of receiving hospital and specialist services where the Ministry directs that the payment of such travelling expenses is in the interest of the public health.

# **General Medical and Pharmaceutical Services**

REGULATIONS, DATED 23RD APRIL, 1951, MADE BY THE MINISTRY OF HEALTH AND LOCAL GOVERNMENT UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND), 1948.

# 1951. No. 62

The Ministry of Health and Local Government for Northern Ireland, in exercise of the powers conferred on it by sections six, twelve, and thirteen of the Health Services Act (Northern Ireland), 1948, hereby makes the following Regulations :--

1.—(1) These Regulations may be cited as the Health Services (General Medical and Pharmaceutical Services) (Amendment) Regulations (Northern Ireland), 1951, and shall come into operation on the first day of May, 1951.

(2) The Interpretation Act, 1921, shall apply for the purpose of the interpretation of these Regulations in like manner as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. The Health Services (General Medical and Pharmaceutical Services) Regulations (Northern Ireland), 1948 (a) (hereinafter referred to as "the Principal Regulations") shall be amended as follows :---

(1) The lists of prescribed appliances and chemical reagents contained in Parts I and II of the Schedule to these Regulations shall be substituted for the corresponding lists in the Second Schedule to the Principal Regulations as amended by Regulation 5 of the Health Services (General Medical and Pharmaceutical Services) (Amendment) Regulations (Northern Ireland), 1949 (b).

(2) For sub-paragraph (2) of paragraph 3 of Part I of the Third Schedule to the Principal Regulations there shall be substituted the following sub-paragraph :---
