

Dried green fodder crops

Any product which

- (a) is obtained by artificially drying any green crop or crops suitable for use as dried fodder for cattle or poultry, and
- (b) is otherwise as grown (that is to say, including any growths harvested therewith but with no other substance added thereto), and contains not less than 10 per cent. albuminoids (protein) calculated on the assumption that it contains 10 per cent. moisture,

but is not dried grass or dried grass (maintenance quality).

Dried green roughage

Any product which contains less than 10 per cent. albuminoids (protein), calculated on the assumption that it contains 10 per cent. moisture, but which in all other respects complies with the definition of dried grass or dried green fodder crops.

FIRE SERVICES

Standard Fire Provision

REGULATIONS, DATED 19TH APRIL, 1951, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SUB-SECTION (2) OF SECTION FOUR OF THE FIRE SERVICES ACT (NORTHERN IRELAND) (REPRINT), 1947, AS AMENDED BY THE FIRE SERVICES (AMENDMENT) ACT (NORTHERN IRELAND), 1950.

1951. No. 63

The Ministry of Home Affairs, by virtue and in exercise of the powers conferred upon it by sub-section (2) of section Four of the Fire

Services Act (Northern Ireland) (Reprint), 1947, as amended by the Fire Services (Amendment) Act (Northern Ireland), 1950, and of all other powers enabling it in that behalf, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Fire Services (Standard Fire Provision) Regulations (Northern Ireland), 1951.

(2) The Interpretation Act, 1889, shall apply to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

(3) In these Regulations, unless the context otherwise requires—
“ the Act ” means the Fire Services Act (Northern Ireland) (Reprint), 1947, as amended by the Fire Services (Amendment) Act (Northern Ireland), 1950 ;

“ the Ministry ” means the Ministry of Home Affairs ;

“ the Authority ” means the Northern Ireland Fire Authority ;

“ Fire Force Commander ” means the officer appointed by the Authority under paragraph (a) of sub-section (1) of section six of the Act ;

“ breathing apparatus ” means apparatus, of a type approved by the Ministry, the function of which is to enable a wearer thereof to work in an atmosphere incapable of supporting human life ;

“ country appliance ” means a major pumping appliance carrying a ladder extending to not less than 30 feet, of a type approved by the Ministry, capable of delivering water at a rate of not less than 350 gallons a minute, together with hose and ancillary equipment of such types and in such quantities as may be approved by the Ministry ;

“ emergency tender ” means a self-propelled vehicle carrying such equipment for use in the protection of life and property in case of fire as may be approved by the Ministry ;

“ fire boat ” means a power-driven boat of a type approved by the Ministry, fitted with pumps, hose and other equipment of such types and in such quantities as may be approved by the Ministry ;

“ foam apparatus ” means apparatus, of a type approved by the Ministry, the function of which is to produce and deliver foam of a kind used for the extinction of fire ;

“ mobilising section ” means a section of a fire brigade provided with telephones and such other equipment as may be needed for the purpose of carrying out the following functions :—

(1) the reception of calls for the service of a fire brigade in case of fire ;

(2) the maintaining of records of the availability for immediate use of appliances and equipment ; and

(3) the summoning of members of a fire brigade when required ;

“ part-time station officer ” means a part-time member of a fire brigade appointed to be the leader of a group of part-time members ;

“ retained members ” means part-time members of a fire brigade who undertake, in return for retaining fees, to hold themselves available for duty with the brigade when required ;

“ town appliance ” means a life-saving dual-purpose appliance carrying a 50 foot wheeled escape, of a type approved by the Ministry, capable of delivering water at the rate of not less than 450 gallons a minute, together with hose and ancillary equipment of such types and in such quantities as may be approved by the Ministry ;

“ turntable ladder ” means a self-propelled vehicle embodying a power-operated elevating and rotating ladder of a type approved by the Ministry extending to not less than 80 feet.

2. The standard fire provision to be made by the Authority shall be as set forth in the Schedule to these Regulations.

3. These Regulations shall come into force on the date hereof.

4. The Fire Services (Standard Fire Provision) (Northern Fire Authority) Regulations (Northern Ireland), 1947, (a) the Fire Services (Standard Fire Provision) (Southern Fire Authority) Regulations (Northern Ireland), 1947, (b) the Fire Services (Standard Fire Provision) (Western Fire Authority) Regulations (Northern Ireland), 1947, (c) the Fire Services (Standard Fire Provision) (Belfast Fire Authority) Regulations (Northern Ireland), 1949, (d) the Fire Services (Standard Fire Provision) (Northern Fire Authority) Regulations (Northern Ireland), 1950, (e) the Fire Services (Standard Fire Provision) (Western Fire Authority) Regulations (Northern Ireland), 1950, (f) and the Fire Services (Standard Fire Provision) (Southern Fire Authority) Regulations (Northern Ireland), 1950, (g) are hereby revoked.

SCHEDULE

STANDARD FIRE PROVISION TO BE MADE BY THE AUTHORITY

Fire Brigades.

1. The fire brigades of the fire force of the Authority shall be so constituted as to fulfil the following requirements :—

(1) the personnel shall comprise —

- (a) a whole-time Fire Force Commander and at least eighteen whole-time fire officers, of whom there shall be at least one continuously on duty in Londonderry ;
- (b) a sufficient number of whole-time firemen stationed at Londonderry to provide for the continuous attendance of at least twelve men ; and
- (c) a sufficient number of retained members to provide for the adequate manning at all times of the fire engines and appliances specified (other than for the County Borough of Londonderry) in columns (1), (2) and (3) of the table in the next succeeding sub-paragraph.

(2) The fire engines, appliances and equipment (other than equipment provided for members' personal use) and the location thereof shall be as indicated in columns (1), (2) and (3) of the following table and in sub-paragraph (3) of this paragraph.

In addition the Authority shall provide breathing apparatus and foam apparatus of such types and in such quantities as may be approved by the Ministry.

(3) The Authority shall provide each member of a fire brigade with such uniform and other equipment for his personal use as may be approved by the Ministry.

Training of Firemen.

2. It shall be the duty of the Authority to ensure that every fireman receives such training in his duties, under the supervision of the Fire Force Commander or a fire officer, as may be approved by the Ministry, and the Authority shall maintain or cause to be maintained such records of training as may be specified by the Ministry.

3. The arrangements for enabling persons to call a fire brigade in case of fire, for summoning the members of a fire brigade and for manning the fire engines and appliances, shall be as follows :—

- (1) The Authority shall provide and maintain mobilising sections at their Headquarters in Lisburn, and, so far as may be necessary in the interests of efficiency, at Londonderry, Portadown and Ballymena.
- (2) The Authority shall make such arrangements as will ensure that calls for a fire brigade in cases of fire will be transmitted promptly to a mobilising section.
- (3) The Authority shall provide and maintain in every town mentioned in column (3) of the table in sub-paragraph (2) of paragraph one of this Schedule in which there are retained members of a fire brigade apparatus of sufficient power to give audible warning for the purpose of summoning the members to man the fire engines and appliances, and shall make suitable arrangements for the sounding of the said apparatus when necessary.

4. When a fire brigade respond to a call in case of fire, a fire officer or a part-time Attendance station officer shall, if practicable, attend at the fire in order to take charge of the operations of the brigade.

FISHERIES

Boards of Conservators (Representation)

ORDER DATED 24TH MAY, 1951, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND, UNDER SECTION 10 OF THE FISHERIES ACT (NORTHERN IRELAND), 1949.

WHEREAS the BALLYCASTLE BOARD OF CONSERVATORS the COLERAINE BOARD OF CONSERVATORS and the ENNISKILLEN BOARD OF CONSERVATORS have, in pursuance of Section 1 (3) of the above Act (hereinafter referred to as "the Act") and each of them has determined and each has by resolution dated respectively 11th day of November, 1950, 21st day of January, 1950, and 17th day of January, 1950, resolved that an annual licence duty of the amount set out in the second column of Part IV of the First Schedule to the Act shall be payable under Section 8 of the Fisheries (Ireland) Act, 1848, in respect of any single rod (referred to as a "trout rod") used in their and each of their districts for taking trout, perch, pike, or other fish (not being salmon).

AND WHEREAS in the circumstances set forth in the foregoing recital the Ministry is empowered by Section 10 of the Act so to amend the First Schedule to the Fisheries Act (Northern Ireland), 1934, in relation to the board of conservators in any district in which a licence duty in respect of a trout rod becomes payable, as to provide for the election thereto of such members representative of the holders of trout rod licences as may be specified in the Order subject as in said Section 10 is provided.
